PROCEDURE FOR ADMISSION UNDER THE CATEGORY OF NRI/NRI SPONSORED

1. The candidates whose names are mentioned in the CLAT-2017 NRI/NRI Sponsored Merit List (available on www.nliu.ac.in), are required to:
 - (i) make an application expressing their interest for seeking admission in the prescribed Expression of Interest Form-I (given below),
 - (ii) deposit an amount of ₹1,00,000/- (Rupees One Lac Only) only through electronic mode using SBI collect payment option (<https://www.onlinesbi.com/prelogin/icollecthome.htm>) latest by 6th June 2017 in NLIU Bhopal's account, and
 - (iii) submit the Duly filled-in Form-I at admission@nliu.ac.in latest by 05:00 p.m. of 7th June, 2017.
2. Submission of the Form-I through any other mode shall not be accepted. The names and other details of the candidates, whose Form-I have been received as per the above prescribed mode will be displayed at www.nliu.ac.in by 01:00 p.m. on 8th June, 2017. If the name of a candidate who has complied with the conditions given in para 1 above but his/her name is not appearing in this list, he/she may contact the university latest by 01:00 p.m. of 9th June 2017 failing which no request in this regard shall be entertained by the university.
3. A candidate who fails to comply with any of the three conditions given in para 1 above, it shall be conclusive that he/she is not interested in taking admission at NLIU Bhopal in NRI/NRI Sponsored category. Consequently, this offer for admission shall stand automatically withdrawn and his/her seat shall be treated as vacant and this vacant seat may be offered to the candidate next in merit, and no request shall be entertained by the NLIU in this regard.
4. The amount of ₹1, 00,000/- is non refundable but adjustable in the fee payable by the candidate. However, the amount of ₹99,000/- will be refunded to the candidate if: (i) a candidate admission status is changed i.e. admitted in other category or moved to their higher preference by the CLAT-2017, or (ii) he/she is not admitted to NLIU, Bhopal. For claiming refund candidates are required to send deposit details and bank account details for the refund of amount ₹99,000/- after the deduction of processing fee i.e. ₹1,000/- (if eligible for refund) along with the Forms-I & II (given below).
5. A merit list, strictly according to CLAT-2017 Rank, of the candidates whose Form-I along with payment has been received in time will be published by 05:00 p.m. of 9th June 2017 at www.nliu.ac.in.
