11 Library

Library is a hub for the information resource storage and dissemination in the field of law and allied subjects. It serves as partner in supporting the teaching, learning and research activities of the university. It is located centrally in a very magnificent, aesthetically designed building called the Gyan Mandir, a temple of knowledge. 11.4 E-resources

Electronic publishing with advanced communication technologies have opened up the possibility of

instantaneous access and dissemination of information as it is created. The trend is challenging the elimination of selection process. However quality, library relevancy, aesthetic, technical and the cost aspects remain the same in the electronic era of information. 11.5 Automation

SCHEDULE 17: SIGNIFICANT ACCOUNTING POLICIES AND NOTES TO ACCOUNTS AS AT 31st MARCH, 2014

A. SIGNIFICANT ACCOUNTING POLICIES

1. BASIS OF ACCOUNTING

The accounts of the Institution are prepared under the historical cost convention and in accordance with Applicable Accounting Standard. Accounting policies not specifically referred to are consistent with Generally Accepted Accounting Practices. The Institution follows Cush basis of Accounting and recognizes Income and Expenditure on Cash basis except Legal Expenses, Audit Expenses, Electricity Expenses and Telephone Expenses.

2. GRANT IN AID

Non-Recurring Grants: Grants of the nature of Contribution towards Capital Expenditure is shown under Earmarked fund and to the extent utilized in the year are treated as part of Capital Fund.

Recurring Grants: Grant received for meeting the Revenue Expenditure are recognized in the Income and Expenditure Account to the extent of Revenue Expenditure incurred during the year.

3. CAPITAL FUND ACCOUNT

Capital Fund is created with the amount transferred from Farmarked Fund as utilized for Building Construction & Expenditure incurred on other Assets.

4. FUND ACCOUNT

Earmarked and Endowment fund created from Grant received in the nature of Capital from M.P. Government and UGC is accounted in accordance with $\Delta S = 12$.

5. CURRENT LIABILITIES AND PROVISIONS

Current liabilities includes:

- (A) Earnest Money Deposit
- (B) Rajiv Gandhi Advocate Training
- (C) Contributory Provident Fund.
- (D) Scholarship Fund.

6. FIXED ASSETS

Fixed Assets are stated at Cost less Accumulated Depreciation. The cost of an asset comprises its purchase price and any directly attributable cost of bringing the asset to working condition for its intended use. Expenditure for additions, improvements and renewals are capitalized and expenditure for maintenance and repairs are charged to Income and Expenditure Account. Fixed assets acquired out of Capital Funds are stated at cost and corresponding grant shown as Capital Funds under Liabilities.

7. DEPRECIATION

Depreciation is charged as per Income Tax Act 1961. No depreciation is charged on Building under Construction.

B. NOTES TO ACCOUNTS

1. FIXED ASSETS

In cases where the assets are purchased out of project grants for use in the projects and no specific commitment exist, the equivalent amounts of the assets so purchased are treated as Capital Funds.

The Capital Fund during the year includes Building under Construction Rs. 3,87,90,465.00. and other Fixed Assets Rs. 51,23,393.00

During the year Health Care Center 4,97,0523.00, Professor housing of Rs 11,94,307.00, Warden Residence of Rs 2,36,972.00, Sr. Staff Quarter of Rs.2,55,42,505.00, Girls hostel of Rs 4,55,452.00, Building Construction State Government Fund(5000000) of Rs. 4,54,643.00 & Building under merged scheme XI Plan for Rs 1,79,56,450.00 is also added to Building under Construction which includes amount of Rs. 1,20,20,387.00 incurred out of own fund

2. Work Completion Certificate has not been obtained for the 2nd Academic Block amounting to Rs.3,85,59,986.00 for which the Construction work has been Completed and is put to use, which is not yet transferred to Fixed Assets and Depreciation is not charged on the same due to which the profit is overstated. The same has been received During the year 2014-15.

3. EARMARKED EMDOWMENT FUND ACCOUNT

- a) An amount of Rs. 93,29,262.00 was incurred by the University from its own fund in the year 2011-12 and has been carried forward in the year 2012-13, against which an amount of Rs. 56,99,562.00 has been received. The balance amount of Rs. 36,29,700.00 is still to be received.
- b) The excess expenditure of Rs. 11,913.00 was incurred by the university from own fund for UGC for Computer Development under XI Plan during the year 2011-12 remains receivable.
- c) The excess expenditure of Rs.22,35,755.80 was incurred by the university from own fund for General Development XI Plan during year 2013-14 remains receivable.
- d) The excess expenditure of Rs.28,96,762.00 was incurred by the University for XI Plan (Merged Scheme) which remains receivable.
