In the year 2019, the NLIU Law Review introduced a new event to the University by signing a 5 year MOU with India Foundation New Delhi and organising 1st NLIU - India Foundation Constitutional Law Symposium and Paper Presentation Competition.

The aim of the Symposium is to provide a platform for a discussion on Contemporary Constitutional Law Issues in India. Panel discussions happened on topics such as Faith and Indian Constitution and Freedom of Speech and Expression in age of social media. Notable figures like ASG Vikramjeet Banerjee, Sabrimala Case Lawyer J Sai Deepak, Former SC Judge Justice AP Mishra, Former VC of NLSIU Prof NL Mitra were part of the panel.
