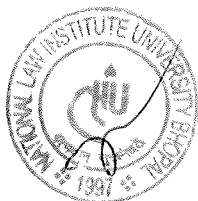

The contractor should have been in the business of Internal & external Electrical works, at least 3 years.

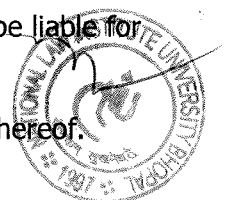
OR

The bidder should be an 'A/B' Class Electrical Contractor having experience of Internal & External Electrification.

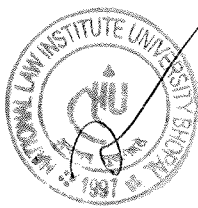
The track record of the contracting firm/contractor should be clean and should not have any involvement in illegal activities or financial misappropriation /frauds etc.

### **Instructions to Bidder**

1. Bidders are advised to study all instructions, forms, terms requirements and other information in the quotation carefully. Submission of Bid shall be deemed to have been done after careful study and examination of the quotation with full understanding of its implication. The response to the quotation should be full and complete in all respects. Failure to furnish the information required by the quotations or submission of a proposal not substantially responsive to the quotation in every respect will be at the bidder's risk and may result in rejection of its proposal. The Quotation is not transferrable to any other Bidder.
2. Proposal after due date and time shall not be accepted.
3. The bidders are advised to go through the guidelines and instructions, as provided on the website, and in case of any difficulty related to, may contact the helpline number 0755-269670. The Bidder shall submit the proposals as described below-
  - a) Signed on each page and should be filled in the prescribed format only.
  - b) Proposal that are incomplete or not in prescribed format may be rejected.
  - c) The agency shall submit A/B Class Electrical Licence along with the TENDER.
  - d) Conditional proposals shall not be accepted. If any clarification is required, the same should be obtained before submission of the bids.
  - e) Any alteration, erasures or overwriting shall not allow.
  - f) Payment shall be made after completion of work.
  - g) Time of completion of work shall be 30days from the date of issue of work order.
4. The authorized person of the contracting firm/contractor must put his signature on all the pages of the tender invariably in having accepted all the terms and conditions in respect of this tender work.
5. The bidder must be registered with 'A/B' Class licence, GST No and should have PAN from Income Tax Department.
6. It may be noted that tenders not accompanied by any of above documents will be liable for rejection.
7. NLIU reserves the right to reject any or all offers without assigning any reason thereof.



8. Any changes, addition or deletions in the tender will be available on the website [www.nliu.ac.in](http://www.nliu.ac.in). No separate written communication will be circulated.
9. The Bidder can inspect the site from 02/08/2022 to 19/08/2022 after taking prior appointment between 11.00 AM to 4.00 PM on all working days. No extra charges shall be payable for non awareness of the site/equipments conditions and constraints. Water & Electricity shall be provided free of cost.
10. Payment shall be made after the satisfactorily completion of works.
11. The price quoted should be inclusive of all Taxes/GST and Duties.
12. Cost of tender non-refundable.
13. EMD of successful bidder shall be refund after the completion of work. EMD of unsuccessful bidder shall be refund after the finalization of the party.
14. A penalty of 2% of the total order value will be imposed per week for late completion of work



## **General Terms and Conditions**

1. NLIU shall have the right to forfeit EMD of the contractor under this contract, if the contractor commits breach of any of the terms and conditions or fails to perform to the satisfaction of NLIU and the quality of performance of contract with regard to maintenance work is found unsatisfactory. Besides, NLIU shall also have the right to terminate.

### **2. Disputes Resolution:**

All questions, disputes and/or difference arising under or in connection with this work or in any way touching or relating to or concerning the work, meaning or effect or the terms herein, shall be referred to the sole arbitration of Vice Chancellor, NLIU. The award of the arbitrator so appointed shall be final and binding. All disputes shall be jurisdiction of courts of District Bhopal only.

- (i) The Contractor shall not be allowed to carry away any material/item out of the Building & Campus without the prior permission of NLIU. The Contractor shall co-operate with the other Contractors working in the Building & Campus.
  - (ii) The disposal of scrap/cartoons of electrical materials related to work in the substation or any area inside the Building & Campus will not be dumped or left unattended anywhere in the Building & Campus and will be disposed off outside the Building & Campus properly without fail.
  - (iii) The Contractor should take all precautionary measure to ensure the safety of his workmen and NLIU shall not be responsible in case of any eventuality. The insurance indemnification of his workman against any eventualities shall be primary and sole responsibility of the contractor.
  - (iv) NLIU reserves the right to reject any particular workman/staff employed by the Contractor under contract with it without assigning any reason thereof. Such staff will have to leave the Building & Campus at short notice and will be replaced by the suitable substitute.
