Terms and Conditions:

1. Sealed bids are invited for Supply of Newspapers at NLIU.
2. The bidders should quote their lowest charges (if any) and highest discount based upon the Terms and Conditions forming part of tender document.
3. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received/opened on the next working day.
4. The right to accept a bid will rest with the Registrar, National Law Institute University, Bhopal.
5. In case, the vendor fails to comply with the terms & conditions, the Institute may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
6. The successful bidder will be liable to supply the enlisted newspapers & magazines as per the quantity required, which may be increased or decreased at any time.
7. Addition or deletion of any newspaper or magazines may be done at any point of time by the Registrar, National Law Institute University, Bhopal.
8. The bidder has to supply all the newspaper and produce a bill which should be not more than the actual price of the concerned newspaper viz. Maximum Retail Price printed on the respective newspaper.
9. It will be the responsibility of the vendor to pack the material by his own laborers and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself or if any charges applicable that must be clearly mentioned in the financial estimate (Annexure 1)
10. The Vendor has to supply the newspapers in the morning on or before 09:00 AM by doing every possible and feasible effort to provide latest edition.
11. The Vendor has to supply the daily newspaper as per the requirements to Library/Hostels/Guest House/Departments and any other location specified by the University within the premises.
12. Preference will be given to those vendors who will supply the newspaper and magazines without any additional charges with the highest discount.
13. The Vendor has to Supply all the Newspapers as mentioned in the list.
14. The duration of this supply is 01 Year which may be extended up to 03 terms.
15. If required, Job may be allotted to more than one vendor
16. Rates may be revised as per the revision of rates from the publisher
17. Work for supply of news paper and periodicals may be given to separate vendors
18. Vendor should have the authorization to sell the item from the respective publisher whose material is being sold.
19. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
20. It will be the responsibility of the vendor to pack the periodicals by his own laborers and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself
