Sealed quotations are invited by Registrar on Behalf of University from reputed Licensed Firms/Contractors/Agencies experienced in similar nature of work of "Providing and fixing UV Stabilized fiberglass reinforced plastic sheet on the Boundary wall of VC residence" at NLIU, Bhopal. The agency has to mandatorily visit the site to understand the nature and extent of job, for proper inspection of the work and their quoted rates should be inclusive of material, and labour complete in all respect. **The Agency has to enclose its self-attested copies of PAN Card and GST Number along with the sealed envelope.** The quotations with specific rates for the under mentioned item will be received up to 12.00 pm on 27.06.2023 and will be opened on the same day at 3.30 PM. Terms and Conditions:

1. Sealed Quotations are invited for "Providing and fixing UV Stabilized fiberglass reinforced plastic sheet on the Boundary wall of VC residence at NLIU, Bhopal".
2. The work will be carried out as per CPWD/MPPWD General Specifications for Civil works amended up to date & as per the instructions of the Engineer-in-charge.
3. The work is of urgent nature and is to be completed within 10 days after issue of work order.
4. All damages done during execution of the work is to be made good by the contractor and nothing extra will be paid separately for the same.
5. The bidders should quote their rates based upon the Terms and Conditions forming part of quotation document.
6. In case, the date of submission/opening of tenders happens to be holiday, the tenders



- shall be received / opened on the next working day.
7. The right to accept a bid will rest with the National Law Institute University, Bhopal.
 8. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
 9. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
 10. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
 11. The University may increase/decrease the scope of the work up to 10% of the total work.
 12. Contractor shall abide by labour rules and regulations.
 13. All the applicable taxes shall be deducted from bill.
 14. Compensation of delay of work will @ 0.05% per day on account of non-completion of work within stipulated period.
 15. All material to be used on the work will have to be got approved from the Engineer-in-charge
 16. Certificate of enlistment with Central/State Govt. Organization/Central Autonomous body/Central Public Sector Undertaking should also be attached with NIQ.

1	Providing and fixing UV stabilised fibreglass reinforced plastic sheet roofing upto any pitch including fixing with ploymer coated J or L hooks, bolts and nuts 8 mm dia GI plain/bitumen washers complete but excluding the cost of purlins, rafters, trusses etc. These sheets shall be manufactured out of 2400 TEX panel rovings incorporating minimum 0.3% Ultra-violet stabilisher in resin system under approximately 2400 psi and hot cured. They shall be of uniform pigmentation and thickness without air pockets and shall conform to IS 10192 and IS 12866. The sheets shall be opaque or translucent, clear or pigmented, textured or smooth as specified. 2mm thick flat. The sheet shal be fitted on iron/structural steel frame complete in all respect.
