- 1) The University having 8 old LCD and LED projectors Epson & LG Make which the University is offering a buy back option with the new projectors which is mandatory for all bidders to quote the buy back rate of projectors in the Financial Bid. The bidders are advised before quoting the buy back rate shall visit the NLIU Campus for the inspection of the Projectors installed as and where.
- 2) Other details can be seen in the complete tender documents which shall be made available on e-portal <https://mptenders.gov.in> and www.nliu.ac.in/tenders and can be downloaded from the portal.
- 3) Tender documents can be submitted **only online from e-portal <https://mptenders.gov.in>**. Details of tender document shall also be available on the website www.nliu.ac.in/tenders
- 4) The bid should be filled online and the documents which are to be uploaded by the bidders should be submitted online within time schedule as mentioned in Key Dates.



- 5) The relevant portion of tender which tenderer have to fill online would be available on above website as per date mentioned in the tender document. The university reserves the right to reject any or all the tender or accept any tender in full or part as considered advantageous to the university, whether it is lowest or not, without assigning any reason whatsoever it may be.
- 6) Since the online bidders are required to sign their bids online using class III Digital Certificates only, hence they are advised to obtain the same at the earliest. Bidders intending to participate in the Tender are required to get themselves trained on the e-Procurement System of MP Tender.
- 7) No offer will be accepted without valid Earnest Money Deposit except for MSME. At the time of opening of tender, it is revealed that EMD amount is inadequate/ any other discrepancy is noticed, the offer shall be rejected.
- 8) The corrigendum or addendum to the bidding documents, if any, as well as any change in due date(s) of opening of tender will be published on the website: <https://mptenders.gov.in> & also on university website <http://www.nliu.ac.in> and will not be published in newspapers. Hence, participant bidders are advised to regularly visit the websites and portal for latest information in this regard. The university shall not be responsible for any ignorance of the bidders about the corrigendum or addendum or change in the due date.
- 9) No physical submission of Bid is required. The date of opening of Technical Bid shall be 04.07.2023 and the date financial bid will be open on 06.07.2023
- 10) The Tender document will be available on portal <https://mptenders.gov.in> on or before from **20.06.2023 to 04.07.2023 till 03:00 PM**. The interested bidders are advised to regularly visit the portal for purpose.
- 11) If any of the above happen to be a holiday, the next working day will be the due date.



INSTRUCTIONS TO THE BIDDER

- 1) Attention of the tenderer is directed to the conditions of tender and general conditions of the contract of NLIU. The Bidder must read the terms & conditions before submission of the tender.
- 2) The time for supply, installation and Commission of work is 20 Days & will be reckoned from the date of issue of Work Order.
- 3) The Bid Validity Period is 60 Days.
- 4) The bidders are required to invariably upload the documentary evidence of submission of **In ENVELOP-A (Technical and Commercial Bid)**
 - a) Tender cost/EMD,
 - b) Annexure – A Technical Compliance Report
 - c) Annexure -B Checklist along with all supportive documents regarding meeting the technical eligibility criteria.

In ENVELOP-B (Financial Bid)

- a) Financial Bid
- 5) The Earnest Money received shall be refunded to the unsuccessful bidders without any interest, after the finalization of the party. The Earnest Money Deposit (EMD) of the successful tenderer shall be refunded after the work completion.
- 6) Earnest Money Deposit (EMD) will be forfeited in the following cases –
 - a) If the tenderer withdraws/modifies his tender during the period of Bid Validity.
 - b) If the tenderer does not accept the correction of arithmetical errors of his tender.
 - c) If the tenderer after awarding of work, does not start the work within the stipulated time period as per Letter of Acceptance / Work Order.

Eligibility Criteria

Contractors who fulfil the following requirements shall be considered as Eligible Bidder:

- 1) The Bidder Should have provided similar nature of Services (Please enclosed all supportive documents at technical bid) at least 05 (Five) Projector supply with installation to NLU's/Govt. Departments/Semi Government Departments/PSU/Educational Institutions of National Importance etc. During Last 3' (three) years. Duly Certified order Copies are to enclosed. Authorization certificate from OEM for Price Quote
- 2) A Self attested Photocopy of GST of firm issued by concerned department.
- 3) Part shipment for any items will not be allowed.



- 4) A Self attested Photocopy of PAN card of the firm issued by the Income Tax Department.
- 5) Self- attested photocopy of certificate of Shops Establishment.
- 6) The Bidder should not have been blacklisted by any Government/PSU organization.

Terms & Conditions

- 1) The bidding agency should be reputed firm and having all necessary certificates, viz. VAT registration Certificate, PAN, Registration, Sale Tax Clearance Certificate, Authorized dealership/ Distributorship certificates, etc. The photocopies of all the certificates should be attached with the tender.
- 2) The firm should be an original manufacturer / Authorized Dealer/ Supplier in the business of Manufacture or supply of business for minimum 3 (three) years.
- 3) The items being quoted should be manufactured by original Manufacturer and no non-standard item should be quoted. All detailed specifications with make & model no. of the items accompanied by proper leaflets should be clearly mentioned and attached with the offer. In case of proprietary or patented item, necessary certificates in support of the same should be attached. The bidder must submit the compliance statement and deviation Statement of technical Specification.
- 4) The firm Should have satisfactorily manufactured/ supplied equipment / component, as requisitioned in this tender, to Govt. Department/ Semi Govt. Department / PSU/ Educational Institutions of National Importance etc. during the last three years ending the last day of March 2022.
- 5) Payment shall be made only after receipt of installation of material in good and working condition as per Specification.
- 6) Warranty period (Five Years) offered for the tendered item is to be clearly specified.
- 7) All Rates, Prices, Amounts and Sums quoted by the bidder shall be in INR only. The language used throughout shall be English.
- 8) All Rates, Amounts & Sums shall have to be quoted in both in figures and words. If the rate quoted in words does not tally with the rate quoted in figures, then the rate which corresponds to the lesser amount shall be considered.
- 9) Tender must be submitted with the rates for all the items of work involved and any incomplete tender documents will not be considered. The items for which the rates are not quoted will be considered as 'Zero' & the agency shall complete that item of work without any claim.
- 10) No alteration shall be made by the party in the quotation and no conditional tender will be entertained. Tenders with a split rate will not be considered.



- 11) The bid shall remain valid for a period of 60 Days from the date of opening of the bid. If before the expiry of the validity period or issue of work order, whichever is earlier, the bidder amends/modifies/withdraws his bid, making it unacceptable to the University, then the Earnest Money Deposit shall be liable to forfeiture at the option of the University.
- 12) The Rates quoted by the party should be clear. All the column of the price bid should be filled carefully. No claim on this account whatsoever shall be entertained at any stage including the extended period, if any.
- 13) The Intending bidders will have to produce documentary evidence in original in support of their credentials before the competent authority whenever demanded verification. If any information furnished by the bidder is found false/fabricated then his bid will be rejected and treated as cancelled, even if the same is detected at any stage after signing of the contract and would lead to termination of the contract besides the forfeiture of Earnest Money Deposit (EMD) and liabilities towards prosecution under appropriate law. In such cases, the bidder/tenderer will be debarred from participation in the future tendering process.
- 14) Should there be any doubt or obscurity as to the meaning of any of the tender documents or if any further information is required, the tenderer must address his enquiry in writing to Registrar, National Law Institute University, Kerwa Dam Road, Bhopal – 462044.
- 15) The Bids shall be received on date and time stipulated in the Notice Inviting Tender or Corrigendum otherwise. Tenders that are received after the date and time specified will not be considered.
- 16) All taxes and statutory obligations will be deducted from the bill as applicable from time to time as per Govt. rules.
- 17) The Technical Bids will be opened on the specified date and time. Financial bid will be opened subsequently only for the technically qualified bidders.
- 18) The University reserves the right to accept or reject any or all the offers including the lowest without assigning any reason. The Institute does not bind itself to accept the lowest offer.
- 19) Payment shall be made after the completion of work and the EMD of the successful bidder shall be refunded after the date of completion of work.
- 20) No advance payment will be made, any offer linked with advance payment is likely to be ignored. Payment shall be made after the completion of works.
- 21) After winning the bid, if you fail to complete the work your EMD will be forfeited and you will be blacklisted from participating in any future bid/tender.



- 22) The decision of acceptance of tender will comply with the competent authority of NLIU, who does not bind himself to accept the lowest tender and who reserves the right to himself to reject or partially accept any or all quotations received, without assigning any reason.
- 23) A penalty of 1% of the total order value will be imposed per week for late completion of work or a maximum of @10% of the value of work.**
- 24) Financial bids of those bidders shall be opened who qualified in the Technical Bids.
- 25) The Employer shall be entitled to make any variation of the quality or quantity of the works or any part thereof that may, in his opinion, be necessary and for that purpose, or if for any other reason it shall, in his opinion be desirable, he shall have power to order the contractor to do and the contractor shall do any of the following:
- a) Increase or decrease the quantity of any item up to plus-minus 20% included in the contract.
- 26) The quantities indicated are approximate and may vary at the time of execution. The University will exercise absolute discretion for operating all or some items of the schedule.
