8. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
9. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
10. All the applicable taxes shall be deducted from bill.
11. Compensation of delay of work will @ 0.05% per day on account of non-completion of work within stipulated period.
