- 2. The work will be carried out as per MPPWD General Specifications for Civil works amended up to date & as per the instructions of the Engineer-in-charge.
- 3. The work is of urgent nature and is to be completed within 5 days after issue of work order.
- 4. All damages done during execution of the work is to be made good by the contractor and nothing extra will be paid separately for the same.
- 5. The bidders should quote their rates based upon the Terms and Conditions forming

part of quotation document.

- 6. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
- 7. The right to accept a bid will rest with the National Law Institute University, Bhopal.
- 8. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.

	Dismantling of Existing Cement Asbestos Sheet and placing of new precoated galvanised iron profile sheets (size, shape and pitch of corrugation as approved by Engineer-in-charge) 0.50 mm + 0.05%, total coated thickness with zinc coating 120 gsm as per IS: 277 in 240 mpa steel grade, 5-7 microns epoxy primer on both side of the sheet and polyester top coat 15-18 microns. Sheet should have protective guard film of 25 microns minimum to avoid scratches while transportation and should be supplied in single length upto 12 metre or as desired by Engineer-in-charge. The sheet shall be fixed using self-drilling /self-tapping screws of size (5.5x 55mm) with EPDM seal, complete upto any pitch in horizontal/vertical or curved surfaces excluding the cost of purlins, rafters and trusses and including cutting to size and shape wherever required	450	SqFt
