The bidders are expected to examine all instructions, form, terms & conditions and specifications in the bidding document. The bid should be precise, complete and in the prescribed format as per requirement of the EOI document. The bid should be unconditional. Failure to furnish all information required by the bidding document or submission of a bid not responsive to the bidding document in every respect will be at the bidder's risk and may result in rejection of the EOI.

The firms are advised to visit the site of the University at NLIU, Bhopal Campus, to acquaint themselves regarding the nature and extent of work for Empanelment of Hotels for Boarding, Lodging as per the requirement of the University in an effective and efficient manner.

General Instructions and Terms & Conditions

1. Any EOI received after the scheduled time or incomplete in any manner will not be accepted.
2. The bidder (Individual/firm) is expected to examine all instructions, terms & Conditions, specifications in the EOI form. Failure to furnish information required in every respect will be the Bidders risk and may result into rejection of the bid.
3. Amendment of Bidding Documents: At any time prior to the submission of the bids, the Purchaser may, for any reason, whether at their own initiate or in response to the clarification requested by the prospective Bidder, may modify the Bidding Documents by amendments. The amendment will be notified in writing or by telephone to all prospective Bidders who have received the EOI documents.
4. Signing of Bid The bid shall be typed or written in indelible ink and shall be signed by the Bidder or a person or persons duly authorized to bind the Bidder to Contract.
5. Submission of Bid
 - (a) The EOI will be required to submit the EOI in two bid system in two separate envelopes as mentioned below:

Envelope No. 1 super-scribed as "Technical Bid" should contain an introductory letter of contractor along with copies of documents as evidences. The Individuals/firms/Supplier has to fill up Annexure "A" with his signature along with all supporting documents and samples.
6. Envelop No. II super/scribed as EOI for Financial Bid and should contain the EOI form duly signed in each page by contractor/authorized signatory along with priced bid. The Individual/firm has to fill up Annexure "B".
7. Both Envelope I & II should be placed in large envelope which should be super-scribed As "EOI for Empanelment of Hotels" and addressed to Registrar, NLIU, Bhopal, Madhya Pradesh 462-044.
8. Work order will be issued in advance after checking the availability and in case the Agency / Hotel fails to conduct the programme as per the above specifications and scope of work, the contract of Agency / Hotel will be liable to be terminated.
9. In case of unsatisfactory service provided by the Agency / Hotel or due to other administrative reasons, if the period of stay at the hotel is terminated before the completion of the programme, payment will be released to the hotel / Resort on Pro-rata basis for the actual period of stay of the participants.
10. There is no minimum guarantee of work to any vendor against this empanelment.
11. More than one vendor may be empaneled for this work.
12. NLIU reserves absolute right to take services of any empaneled vendors based on its requirements. No further communication shall be entertained in this regard.

13. NLIU may add or remove any vendor during the empaneled period on its requirement and performance.
14. Further, work may be allocated to one or more than two agencies on the requirement of the university.
15. If the envelope is not sealed and marked, the Purchaser will assume no responsibility for the bid's misplacement or premature opening.
16. Deadline for submission of Bids: Bids must be received by the Purchaser at the address specified under commercial bid not later than 02:00 PM on 21/07/2023.
17. The Purchaser may, at its discretion, extend this deadline for the submission of bids by amending the Bidding Documents in accordance with clause 3, in which case all rights and obligations of the Purchaser and Bidders previously subject to the deadline will thereafter be subject to the deadline as extended.
18. Any defect found in the work carried out by the Agency / Hotel will have to be rectified free of cost by the Agency / Hotel.
- 19. Contacting the Purchaser**
No bidder shall contact the purchaser on any matter relating to its bids, from the time of bid opening to the time the contract is awarded.

20. Evaluation of Bid

- i. The large envelope (containing separate envelope I & II) will be opened first. Thereafter the envelope I i.e. Technical Bid will be opened.
- ii. Those bidders who have not enclosed Technical Bid documents & not submitted. In such cases their Envelope II which contains the financial bid will not be considered.
- iii. The bidders will be pre-qualified in technical bid, who fulfill the following criteria:
 - Valid GSTIN no.
 - Valid PAN no.
 - Valid Bank Account No.
 - IFSC Code
- iv. The envelope II i.e. Financial Bid will be opened for those parties who submitted Technical Bid.
- v. The rate contract shall be valid for one year which can be further extended for two more years based on mutual consent and the satisfactory services.
- vi. The delivery period should be strictly adhered failing which NLIU reserves the right to cancel the order without assigning any reasons whatsoever.

21. Hotel Accommodations/Booking of Rooms:


- i. To provide accommodation on Single/ Double occupancy/ Twin Sharing basis in well-appointed standard accommodation with amenities inclusive of facilities like air conditioning, 24-hour hot water and cold water facility and power supply, cleaned pressed bed sheet, bath towel, hand towel, each day to each occupant / s.
- ii. The check-in time as on or after 12:00 noon and the check-out time from the hotel are before 12:00 noon. Flexibility of check-in / out timing should be considered subject to exigencies.
- iii. NLIU Bhopal shall book different categories of rooms on the basis of its requirement.
- iv. Complimentary Wi-Fi facility must be provided in every room.
- v. Requirement of rooms may vary from time to time and depends on the requirement of NLIU Bhopal. Rooms for guest on single / double occupancy or Rooms in bulk quantity for participants of any programme may be booked.
- vi. NLIU Bhopal will pay only for the boarding and lodging for the Guests / participants. Any personal expense would be borne by the individuals only and to be collected by the Hotel / Resort.
- vii. Complimentary use of facilities like Gym, Swimming Pool and other amenities available at Hotel / Resort premises, if any, needs to be mentioned by Agency / Hotel.
- viii. The Hotel accommodation must have the facility to provide first aid and doctor on call facility for medical emergencies.

22. Eligibility Criteria: -

- i. Agency / Hotel / Resorts should be located and functioning in Bhopal city, having valid licenses and sanctions and qualified experience in the field of Hotel accommodation and catering services. must be submitted along with the technical bid in this regard.
- ii. The Agency / Hotel should have Trade License issued by the appropriate Authority to carry out the business of Hotel.
- iii. The Firm should have PAN Number and GST Registration.

23. Payment

- i. Billing will be on actual check-in / check-out basis for bookings of rooms or on Program basis as per the instruction provided by NLIU Bhopal.
- ii. Payment shall be made on the basis of actual rooms occupied.
- iii. Payment will be made after the completion of the program. Payment shall be made on the basis of actual rooms occupied.
- iv. The bills raised by the Hotel shall clearly mention the billing components (basic tariff, taxes etc.) Check-in, Check-out details of guest(s).

- v. NLIU Bhopal will normally settle the bill within 30 days from the receipt of the bill. However for delayed payment, the Agency / Hotel will not charge any penalty or interest to NLIU Bhopal.
- vi. The payment under this contract shall be made on satisfactory completion of job contract services to be certified by the Administration / concerned department, through NEFT / RTGS / IMPS (online transfer). The final payment shall, however, be made only after adjusting all the dues / claims of the NLIU Bhopal.
- vii. Bill to be made in the name of National Law Institute University Bhopal. TDS / Income Tax etc. are to be deducted at source from the bills of Agency / Hotel as per rule.
- viii. Rates of all items should be inclusive of all taxes, duties and service charges except GST. GST shall be paid extra as per actual.
- ix. No Retention Charges / Surcharges are payable by NLIU Bhopal.
- x. NLIU reserves the right to reject any or all EOI in full or part thereof without assigning any reason.
