- 1. Sealed Quotations are invited for "Construction/Fabrication of Kitchen Cabinet work at NLIU, Bhopal".
- 2. The work will be carried out as per CPWD General Specifications for Civil works amended up to date & as per the instructions of the Engineer-in-charge.
- 3. The work is of urgent nature and is to be completed within 15 days after issue of work order.
- 4. All damages done during execution of the work is to be made good by the contractor and nothing extra will be paid separately for the same.
- 5. The bidders should quote their rates based upon the Terms and Conditions forming part of quotation document.

6. In case, the date of submission/opening of tenders happens to be holiday, the

tenders shall be received / opened on the next working day.

- 7. The right to accept a bid will rest with the National Law Institute University, Bhopal.
- 8. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
- 9. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
