- 1. Sealed Quotations are invited for "Providing, installation, commissioning, and testing of CCTV Network at Library NLIU, Bhopal".
- 2. The work is of urgent nature and is to be completed within 10 days after issue of the work order.
- 3. All damages done during the execution of the work are to be made good by the contractor and nothing extra will be paid separately for the same.
- 4. The bidders should quote their rates based on the Terms and Conditions forming part of the quotation document.

5. In case, the date of submission/opening of tenders happens to be a holiday, the tenders shall be received/opened on the next working day.

6. The right to accept a bid will rest with the National Law Institute University Bhopal.

- 7. In case, the vendor fails to comply with the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
- 8. It will be the responsibility of the vendor for the safety of work and the cost of transportation, packing, loading, unloading, etc. will also be borne by the vendor himself.
- 9. Quotation should reach the Registrar's office as mentioned. The university is not responsible for any kind of postal delay.
- 10. Contractor shall abide by labor rules and regulations.
- 11. All the applicable taxes shall be deducted from the bill.
- 12. The University may increase or decrease the scope of work up to 20% of the total work.

13. Compensation for delay of work will be 0.05% per week on account of non-completion of work within the stipulated period maximum of up to 05% of the awarded value.
