The taxes, if any are to be clearly mentioned in the sealed quotation. The agency shall download the prescribed format our website: [www.nliu.ac.in/tender](http://www.nliu.ac.in/tender).

The quotation should be addressed to the REGISTRAR, NATIONAL LAW INSTITUTE UNIVERSITY, NEAR KERWA DAM ROAD, BHOPAL-462044, superscribing the envelope with "Repairing Work in classroom at Cyber law Center in NLIU, Bhopal".

### **Terms and Conditions:**

1. Sealed bids are invited for "Repairing Work in classroom at Cyber law Center in NLIU, Bhopal". Bid should be sealed in a cover duly super scribed as "Repairing Work in classroom at Cyber law Center in NLIU, Bhopal."
2. The bidders should quote their rates based upon the Terms and Conditions forming part of quotation document.
3. Contractor must visit site before quoting and fully satisfy himself of the site conditions. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
4. No T&P shall be issued to the Contractor. The contractor shall be provided with electricity and water

at one point, he shall make his own arrangements for further distribution of electricity, water supply and all other labour, tools, plant and equipment etc as required for the works complete.

5. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
6. The right to accept a bid will rest with the National Law Institute University, Bhopal.
7. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
8. The successful bidder will be liable to complete the job of "Repairing Work in classroom at Cyber law Center in NLIU, Bhopal" within a period of 15 (Fifteen) days of getting the work order. If the successful bidder does not start work in time or stops the work midway or leaves the work altogether, the University shall have the right to cancel the Order.
9. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
10. All the applicable taxes shall be deducted from bill.
11. All material to be used on the work will have to be got approved from the Engineer-in-charge
12. Payment shall be made as per actual quantities of executed works.
13. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
