The agency can visit the university complex in any working days except government holidays to ascertain about the items. The agency quoted rates should be inclusive of transportation, material, and labour complete in all respect. The Agency has to enclose its self-attested copies of PAN Card/GST, as applicable, along with the sealed envelope. **The Employees of the university are not eligible to participate in this NIQ.** The quotations with specific rates for the mentioned item in the Schedule of Quantity will be received up to 12.00 pm on 08.01.2024 and will be opened on the same day at 3.30 PM. The agency shall download the prescribed format our website: www.nliu.ac.in/tender.

The quotation should be addressed to the REGISTRAR, NATIONAL LAW INSTITUTE UNIVERSITY, NEAR KERWA DAM ROAD, BHOPAL-462044, superscribing the envelope with "Quotation for Various Canteen Items" at NLIU, Bhopal.

Terms and Conditions:


1. Sealed Quotations are invited for "Quotation for Various Canteen Items" at NLIU, Bhopal.
2. The University has the right at his absolute discretion to refuse any bid.
3. The highest bidder shall be the buyer. Dispute between bidders - If any dispute arises between two or more bidders, the university may decide the same or may immediately put the item(s) for sale again, and resell to the highest bidder. The decision of the university shall be final and absolute.
4. Manner of payment - The successful highest bidder-1 has to pay through bank account payment or electronically to "Vice-Chancellor, National Law Institute University, Bhopal" with the Financial Bids of the auction.
5. The selling is to be made on as is where basis All item(s) - are approximate and bidders are mandatory to visit the premises of University buildings, where material is lying.
6. The bidder shall quote the amount in Rupees for each and every items separately.
7. The selling of item(s) is on as is where basis. No claim of any bidder regards any condition of the



- material shall be entertained after the bid submitted by them. The items once sold to the successful bidder shall not be taken back on any condition whatsoever.
8. Time limit for removal of the material shall be 4 days from date of issuance of work order from the office, during office hours.
 9. Delivery, freight and all other charges shall be borne by the Agency and no separate payment shall be made on this account and statutory liabilities i.e. taxes if any is to be paid by the bidder. Any damages caused by the workmen of the contractor to wall, ceiling, floors and fixtures etc., should be made good at the contractor's cost.
 10. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
 11. The right to accept a bid will rest with the National Law Institute University, Bhopal.
 12. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
 13. All the applicable taxes shall be deducted from bill.

The bidder has to submit a EMD of Rs. 5,000/- through bank account payment in the account of the Vice-Chancellor, National Law Institute University, Bhopal and has to attach a receipt for deposit of EMD of the same with the submission of the Financial Bid. **EMD of the successful bidder will be returned on the basis of complete removal of material/items from the site.**
