### PROCEDURE FOR ADMISSION UNDER THE CATEGORY OF J&K RESIDENT

- The candidates who have applied **in the CLAT-2024 under J&K Resident category**, are required to:
  - make an application expressing their interest for seeking admission at NLIU, Bhopal in the prescribed Expression of Interest Form-A (given below).
  - Deposit an amount of ₹50,000/- (Rupees Fifty Thousand Only) only through electronic mode using <https://erp.nliu.ac.in/payment/> latest by 10:00 a.m., of 15.05.2024 in NLIU Bhopal's account.
  - Submit the Duly filled-in Form-A at [admission@nliu.ac.in](mailto:admission@nliu.ac.in) and submit google form for B.Sc.LL.B. (Hons.) [Cyber Security] Course- <https://forms.gle/5DoGZcGywzpqJA8H7> latest by 10:30 a.m. of 15.05.2024.
- Submission of the Form-A through any other mode shall not be accepted. The names and other details of the candidates, whose Form-A have been received as per the above prescribed mode will be displayed at **www.nliu.ac.in** after the deadline of submission of Expression of Interest. If the name of a candidate who has complied with the conditions given in para 1 above but his/her name is not appearing in this list, he/she may contact the university within 2 days after publishing of list of candidates whose forms have been received, failing which no request in this regard shall be entertained by the university.
- A candidate who fails to comply with any of the three conditions given in para 1 above, it shall be conclusive that he/she is not interested in taking admission at NLIU Bhopal in J&K Resident (Supernumerary Quota) category and no request shall be entertained by the NLIU in this regard.
- The amount of **₹50,000/-** is non refundable but adjustable in the total fee payable by the candidate. However, the amount of **₹49,000/-** will be refunded to the candidate if: (i) a candidate admission status is changed i.e. admitted in other category or moved to their higher preference by the CLAT-2024, or (ii) he/she is not admitted to NLIU, Bhopal. For claiming refund candidates are required to send deposit details (Form B) and bank account details for the refund of amount ₹49,000/- after the deduction of processing fee i.e. ₹1,000/- (if eligible for refund) along with the Forms-A (given below).
- A merit list, strictly according to CLAT-2024 Rank, of the candidates whose Form-A along with payment has been received in time will be published at [www.nliu.ac.in](http://www.nliu.ac.in) .
