Terms and Conditions:

1. Sealed Quotations are invited for "Repairing and Servicing of Bus at NLIU, Bhopal".
2. The work is of urgent nature and is to be completed within 07 days after issue of work order.
3. Contractor must visit NLIU campus to inspect the bus no. **MP 04 PA 1548** before quoting and fully satisfy himself of the bus condition. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
4. The bus must be handed back to the university in good condition after completion of various repair/service/painting works etc.
5. The university officials shall inspect the bus properly before taking handover and only upon satisfaction regarding quality of work done. The bus will be accepted and payment shall be released only for such accepted works only.



6. The contractor/agency shall be fully responsible for taking good care of the bus while it's in their possession for carrying out the repair work as mentioned in the NIQ.
7. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received /opened on the next working day.
8. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
9. Contractor shall abide by labour rules and regulations.
10. All the applicable taxes shall be deducted from bill.
11. Compensation of delay of work will @ 1% per week on account of non-completion of work within stipulated period to a maximum of 10% the value of the work.
12. Payment shall be made as per actual quantities of executed works.
13. The right to accept a bid will rest with the National Law Institute University, Bhopal.
14. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
