

Terms and Conditions:

1. Sealed Quotations are invited for "Landscaping work at NLIU, Bhopal".
2. The work will be carried out as per relevant Specifications, BOQ and areas/locations as directed complete.
3. The work is of urgent nature and is to be completed within 30 days after issue of work order.
4. Contractor must visit site before quoting and fully satisfy himself of the site conditions. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
5. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
6. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.



7. Contractor shall abide by labour rules and regulations.
8. All the applicable taxes shall be deducted from bill.
9. Before commencement of the work, the agency has to first develop a patch of the land with grass turf and flowers and after the approval the whole area will be completed.
10. Compensation of delay of work will @ 1% per week on account of non-completion of work within stipulated period to a maximum of 10% the value of the work.
11. All material to be used on the work will have to be got approved from the Engineer-in-charge
12. Payment shall be made as per actual quantities of executed works.
13. The University may order the plants in near future according to rates quoted by the bidder.
14. The rates quoted by the bidder will be valid for a period of 06 months from the date of work order. University can order a greater number of plants according to the requirements of the university.
15. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
16. The right to accept a bid will rest with the National Law Institute University, Bhopal.
17. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
