## Notice Inviting Quotations

Sealed quotations are invited by Registrar on Behalf of University from reputed Licensed Firms/Contractors/Agencies experienced in similar nature of work of Electrical repairing work in the Auditorium Building at NLIU, Bhopal. The agency has to mandatorily visit the Auditorium to understand the nature and extent of job, for proper inspection of the work and their quoted rates should be inclusive of material, and labour complete in all respect. **The Agency has to enclose its self-attested copies of PAN Card, GST Number and Certificate of enlistment along with the sealed envelope.** The quotations with specific rates for the under mentioned item will be received up to 12.00 pm on 23.04.2024 and will be opened on the same day at 3.30 PM. The agency shall download the prescribed format our website: [www.nliu.ac.in/tender](http://www.nliu.ac.in/tender).

The quotation should be addressed to the REGISTRAR, NATIONAL LAW INSTITUTE UNIVERSITY, NEAR KERWA DAM ROAD, BHOPAL-462044, superscribing the envelope with **“Electrical repairing work in the Auditorium Building at NLIU, Bhopal”**.

### Terms and Conditions:

1. Sealed Quotations are invited for “Electrical repairing work in the Auditorium Building at NLIU, Bhopal”.
2. The work will be carried out as per CPWD/MPPWD/BIS Standard Terms and conditions, Specifications, BOQ and areas/locations as directed complete.
3. The work is of urgent nature and is to be completed within 20 days after issue of work order.
4. Contractor must visit site before quoting and fully satisfy himself of the site conditions. No Compensation on account of any site difficulties will be entertained, at a later date, after award of the work.
5. No T&P shall be issued to the Contractor. The contractor shall be provided with electricity and water at one point, he shall make his own arrangements for further distribution of electricity, water supply and all other labour, tools, plant and equipment etc as required for the works complete. Any damage done to existing walls /ceiling /floors /electrical /fire alarm/ fighting/plumbing equipment /building during execution shall be on the part of the Contractor. The bidders should quote their rates based upon the Terms and Conditions forming part of quotation document.



6. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
7. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
8. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
9. Contractor shall abide by labour rules and regulations.
10. All the applicable taxes shall be deducted from bill.
11. **Defect Liability Period:** The Defect Liability period be 12 months. If any defects arise in this period, the bidder has to repair/replace the same without any additional cost.
12. **Payment:** The payment will be made based on the actual measurement after satisfactory completion of the work and taxes will be deducted as per Govt rules.
13. All LED Lights, wires, cables and any other material used must be in conformance with the applicable ISI mark.
14. LED Lights to have minimum higher one year warranty or warranty parts given by the manufacturer.
15. The University may increase or decrease the scope of work up to 10% of the total work.
16. Compensation of delay of work will @ 1.0% per week on account of non-completion of work within stipulated period to a maximum of 10% of the value of the work.
17. All material to be used on the work will have to be got approved from the Engineer-in-charge
18. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the NLIUB Engineers, responsible for supervision of work, on regular basis.
19. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
20. The right to accept a bid will rest with the National Law Institute University, Bhopal.
21. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
