He has worked as Assistant Professor in Jagran Lakecity University in Bhopal, Amity University in Noida, Jaipur National University in Jaipur.

An alumnus of National Law Institute University, Bhopal and Ph.D. (Law) from Barkatullah University, Bhopal, before joining to academia, Dr. Manish has served (2009-2012) as a Consumer Advocacy Officer and Registrar to Electricity Ombudsman in Madhya Pradesh Electricity Regulatory Commission, Bhopal, India.

His primary interest areas include International Commercial Arbitration, Energy Laws, Telecommunications laws and Real Estate Laws. He was Centre in charge of Energy and Telecommunication Laws and Course Coordinator, Postgraduate Diploma in Energy Laws and Policy which is has designed and developed. As a Centre In-Charge has submitted suggestions for the proposed Amendment to Electricity Act, 2003 and also suggested some additional changes in the form of a SEPARATE DRAFT BILL to the Ministry of Power, Government of India.
