

### Terms and Conditions:

1. Sealed bids are invited for disposal of old newspaper/magazines on "As is where condition" basis. Bid should be sealed in a cover duly super scribed as "Tender for Disposal of old Newspaper, Magazines Empty Cartons, Old study material."
2. The bidders should quote their highest rates based upon the Terms and Conditions forming part of tender document.
3. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
4. The right to accept a bid will rest with the Registrar, National Law Institute University, Bhopal.
5. In case, the vendor fails to comply the terms & conditions, the Institute may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such amanner as may be deemed appropriate.
6. The successful bidder will be liable to complete the work of lifting the material from the Library of the Institute within a period of 3 to 5 days of getting the order. If the successful bidder does not start work in time or stops the work midway or leaves the work altogether, the Institute shall have the right to cancel the Order.
7. It will be the responsibility of the vendor to pack the material by his own laborers and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
8. The weighing machine should be certified for proper functioning and this will be verified by the representatives of National Law Institute University, Bhopal. as well as the weighing of old Newspapers and magazines will be done in the presence of representatives of National Law Institute University, Bhopal.
9. Any Statutory variation in the rate of taxes/duties are to be borne by the purchaser. VAT/GST rates as applicable on the date shall be payable by the successful bidders directly to the seller at the time of taking delivery of materials. In order to avoid the imposition of penalty, the amount deposited by the successful bidder towards taxes and duties will be immediately deposited with the concerned tax authorities without waiting for actual delivery.
10. Vendor will be responsible for proper disposal of Old Newspaper and Magazines as per the guidelines of Government/Tribunals from time to time.
