CLAT-2024/NLIU/Admission/Vacancies/01 dated 26.06.2024 and whose names were included in respective lists and deposited the registration fee of Rs. 1,000/-.

2. Category wise vacant number of seats may change and the same will be announced before the scheduled spot counselling.

3. During Spot round counselling to be held at NLIU Bhopal, if there are no candidates in the respective reserve category available, those seats will be converted as per the policy of the University.

4. A candidate desirous of participation in the Spot Counselling has to report between 10:00AM to 12:00 noon on 06.08.2024 for registration and document verification.

5. This offer of admission is provisional and is subject to the available vacancies as per the above procedure and does not create any right to admission in favour of the candidate. NLIU, Bhopal shall not be responsible for any expenditure made by the candidate in this regard. Any false information in this regard shall be illegal and will lead to revocation of this provisional offer and/ or cancellation of admission during the course of study and NLIU shall be at full liberty to take appropriate action against such candidate.

6. A merit list shall be prepared strictly in accordance with CLAT-2024 Rank and only those candidates shall be considered for the preparation of merit list, who will report for the spot counselling within prescribed time period. No request shall be considered for the extension of time.

1. The candidates are required to report in person in the Convention Centre of the University between 10:00 AM to 12:00 Noon on 06.08.2024 along with original and one self-attested photocopy of the following documents:

- iv. Passing Certificate of 12th Class.
- v. 7 passport size photographs.
- vi. Transfer Certificate.
- vii. Migration Certificate.
- viii. Character Certificate.
- ix. Affidavit of intervening period, if there is a gap of one or more year between the qualifying examination and the year 2024.
- x. Admit Card (CLAT-2024)
- xi. CLAT-2024 score Card showing All India Rank
