Notice Inviting Quotations

Sealed quotations are invited by the Registrar on Behalf of University from reputed Licensed Firms/Contractors/Agencies experienced in similar nature of work of Supply of S.S Racks for storing kitchen plates in dining mess at NLIU, Bhopal. The agency has to strictly visit the site and their rates should be inclusive of material, and labour complete in all respect. **The Agency has to enclose its self-attested copies of PAN Card and GST Number along with the sealed envelope.** The quotations with specific rates for the under mentioned item will be received up to 12.00 pm on 08/8/2024 and will be opened on the same day at 3.30 PM. The taxes, if any are to be clearly mentioned in the sealed quotation. The agency shall download the prescribed format our website: www.nliu.ac.in/tender.

The quotation should be addressed to the REGISTRAR, NATIONAL LAW INSTITUTE UNIVERSITY, NEAR KERWA DAM ROAD, BHOPAL-462044, superscribing the envelope with “**Supply of S.S Racks for storing kitchen plates in dining mess at NLIU, Bhopal**”.

Scope of Work:

The Agency has to supply 04 Nos. Stainless Steel Racks meant to hold washed and clean plates. **A picture of the rack is enclosed as Annexure-I.** The Racks supplied should be as per below mentioned technical specifications: -

1. Number of Shelves: 03 Shelves.
2. Number of Plates can be held in each layer: 65
3. Material: Stainless Steel 204.
4. Color: Silver
5. Mount Type: Attached wheel on the lower side.
6. Size of Rack: Length: 72 inches; Breadth: 75 inches; Depth: 15 inches.
7. Load capacity per layer: 200-400 Kg
8. Weight of single rack: Not less than 66 Kg.



Terms and Conditions:

1. The work should be completed within 20 (Twenty) days from the date of the work order.
2. The agency must visit the campus after that they quote their rates which should be inclusive of material and labor complete in all respects.
3. The payment will be made based on the acceptable quality and quantity after satisfactory completion of the work and taxes will be deducted as per Govt rules.
4. It will be the responsibility of the vendor for the safety of work and the cost of transportation, packing, loading, unloading, etc. will also be borne by the vendor himself.
5. The University reserves the right to accept/reject any or all quotations without assigning any reason.
6. Quotation should reach the Registrar's office as mentioned. The university is not responsible for any kind of postal delay.
7. If any accident or mishappening occurs due to poor workmanship, the bidder will be wholly responsible for the same.
8. The contractor must visit the site before quoting and fully satisfy himself with the site conditions. No Compensation on account of any site difficulties will be entertained, at a later date, after the award of the work.
9. The Defect Liability period be 12 months. If any defects arise in this period, the bidder has to repair/replace the same without any additional cost.
10. No T&P shall be issued to the Contractor. The contractor shall be provided with electricity and water at one point, he shall make his own arrangements for further distribution of electricity, water supply and all other labor, tools, plant and equipment etc. as required for the works complete.
11. In case, the date of submission/opening of tenders happens to be a holiday, the tenders shall be received / opened on the next working day.
12. Quotation should reach the Registrar's office as mentioned. The university is not responsible for any kind of postal delay.
13. Contractor shall abide by labor rules and regulations.
14. All the applicable taxes shall be deducted from bill.
15. Compensation for delay of work will @ be 1% per week on account of non-completion of work within the stipulated period to a maximum of 10% of the value of the work.
16. The University may increase or decrease the scope of work up to 20% of the work order.
17. During execution of work, the Engineer may make minor changes in the scope of work as per site conditions or other reasons. The contractor will have no extra claim in his rates for the same.
