3. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
4. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
5. Contractor shall abide by labour rules and regulations.
6. All the applicable taxes shall be deducted from bill.
7. Compensation of delay of work will @ 1% per week on account of non-completion of work within stipulated period to a maximum of 10% the value of the work.



8. Payment shall be made only for the acceptable quantities/plants.
9. The University may order the plants in near future according to rates quoted by the bidder.
10. The rates quoted by the bidder will be valid for a period of 06 months from the date of work order. University can order a greater number of plants according to the requirements of the university.
11. The right to accept a bid will rest with the National Law Institute University, Bhopal.
12. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
