### Terms and Conditions:

1. Sealed Quotations are invited for "customized multi-color **170 playing kit** (T- Shirts + Shorts) for NLIU Bhopal contingent of the NLIU, Bhopal, to participate in Virudhaka - 2024 Sports Fest."
2. Fabric of the playing kit should be minimum 90% polyester (**Full sublimation imported Football texture 180 GSM fabric round neck jersey**). One set of playing kit as sample should be provided with the quotations letter.
3. Printing scope as follows: - chest number, back number, thigh number, player's name at back side, university logo right side on chest. Virudhaka Logo left side of the chest, and sponsor logos.

4. The tenders are informed to quote rates and enclose sample separately and the approved sample's financial bid will be opened.
5. All the sizes, players name and selected chest numbers will be provided with the work order letter to the successful bidder.
6. If any accident or mishappening occurs due to poor workmanship, the bidder will be wholly responsible for the same.
7. The work is of urgent nature and is to be completed within 07 days after issue of work order.
8. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
9. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
10. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
11. Contractor shall abide by labor rules and regulations.
12. All the applicable taxes shall be deducted from bill.
13. Payment shall be made as per actual quantities of supplied items.
14. No extra amount will be paid by the NLIU in any circumstances.
15. The University may increase or decrease the scope of work up to 20% of the order value
16. The right to accept a bid will rest with the National Law Institute University, Bhopal.
17. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
18. Full payment will be released on the actual quantity of the work after delivery of the items as specified.
