The quotations with specific rates for the under mentioned item will be received up to 12.00 pm in tender box kept in the Administrative Block on 20.09.2024 and will be opened on the same day at 3.30 PM. The agency shall download the prescribed format from our website: www.nliu.ac.in/tender.

Terms and Conditions:

- 1. The Vendors are requested to submit their rates including GST with other charges for three days.
- 2. The firm has to make sure that the ambulance must have emergency equipment's i.e., oxygen cylinder, first aid kit, emergency medicines, stretcher and other required tools to meet any emergency situation during the playing.
- 3. The service will be required for three days from 11th to 13th October 2024. The timing of the service will be between morning 9:00 Am to night 9:00 Pm in these three days.
- 4. A maximum run of the ambulance would be around 200 Km. per day to transfer the injured patients to the any hospital with in the city.
- 5. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.

- 6. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
- 7. All the applicable taxes shall be deducted from bill.
- 8. No extra amount will be paid by the NLIU in any circumstances.
- 9. The right to accept a bid will rest with the National Law Institute University, Bhopal.
