- 6. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
- 7. Contractor shall abide by labour rules and regulations.
- 8. All the applicable taxes shall be deducted from bill.
- 9. Payment shall be made as per actual quantities of supplied items.
- 10. The University may increase or decrease the scope of work up to 20% of the order value.
