The taxes, if any are to be clearly mentioned in the sealed quotation. The agency shall download the prescribed format our website: [www.nliu.ac.in/tender](http://www.nliu.ac.in/tender) .

The quotation should be addressed to the REGISTRAR, NATIONAL LAW INSTITUTE UNIVERSITY, NEAR KERWA DAM ROAD, BHOPAL-462044, superscribing the envelope with "**Quotation for Civil Supply material at NLIU, Bhopal**".

**Mode of Submission of Bids:** - Bidders has to submit the bids in **two** separate envelopes as mentioned below:

**1. Envelope-1 Technical Bid**

In this envelope, the bidders have to mandatorily submit the following documents in support of their eligibility: -

- Self- attested GST copy of the firm.
- Self-attested PAN copy.

**2. Envelope-2 Financial Bid**

In this envelope, the bidders have to submit the rates quoted for this work as per the Financial Bids attached with this Notice Inviting Quotation.

**Note:** - **Bidders who will not submit their bids as mentioned above in separate envelope their bids for this work will not be considered.**



**Terms and Conditions:**

1. The materials should be supplied within 7 days from the date of confirmation of acceptance of the quotation.
2. The material supplied should be strictly as per the applicable ISI mark, where ever applicable.
3. The bidder shall mention the Warranty period of the material for which the rate is offered by him (if applicable).
4. The bidder shall quote the rates for all materials including any Transportation and labors etc.
5. GST rate as applicable shall be mentioned clearly.
6. **The rate quoted shall be valid for 90 days for its acceptance.**
7. **The quotation/ bid shall be accepted depending on the total lowest amount quoted for all items. The bidder who quoted total lowest amount will supply all the materials irrespective of the individual lowest rate.**
8. In case of rejection of material, one more chance shall be given for its replacement with the material conforming to the specification specified. Failure to supply the material as per the specification will result in debarring the bidder for participation in bids for a minimum of one year.
9. No advance payment will be made. The payment shall be made within 30 days from the date of supply of material along with the bill. No interest will be paid for delayed payments if any.
10. The rate quoted should be firm. No claim for enhancement of rate is admissible after opening of the Quotations.
11. It will be the responsibility of the vendor for the safety towards supply and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.
12. The University reserves the right to accept/reject any or all quotations without assigning any reason.
13. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
14. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be opened on the next working day.
