ABOUT

NLIU Bhopal

Located in the heart of India, amidst the picturesque hills of the Vindhyas, NLIU, Bhopal was established in 1997 by the Rashtriya Vidhi Sansthan Vishwavidhyalaya Adhiniyam 1997 passed by the Madhya Pradesh Legislative Assembly. It is the second National Law University to be established in the country, and has been recognised by the Bar Council of India (BCI) and the University Grants Commission (UGC).

With the **Hon'ble Chief Justice of India as its patron**, NLIU is a member of the Association of Indian Universities. It also works closely with the High Court of Madhya Pradesh & the National Judicial Academy situated in Bhopal. As one of India's premier law schools, the University endeavors to enhance the legal landscape of India and contribute to the society with the help of its experienced faculty and bright young minds.

The vision of NLIU is to become one of the best centers of legal education, training, and research so that the graduating lawyers profoundly commit to this noble profession. The University has made significant strides in promoting the holistic development of its students by organising a wide array of co-curricular events aimed at enhancing practical legal skills. It has provided an excellent platform for its students to grow as independent individuals capable of making meaningful contributions in their chosen path of life.

ACADEMIC STRUCTURE AND PEDAGOGY

The university follows a robust teaching methodology which is a combination of classroom lectures accompanied by presentations and field studies. This methodology ensures that students are taught in a comprehensive manner, such that they are equipped with the ability to approach legal issues with a broad outlook, therefore leading to their all-rounded development as legal professionals. Each faculty member creates extensive study material and ancillary resources, which are regularly revised and updated to ensure that the syllabus is in line with current legal affairs. The subject is not restricted to just academic studies but is all-encompassing so that the class lectures offer a deeper understanding of each subject.

The University follows an intensive Semester System for its B.A. LL.B. (Hons.) Program, wherein each year is divided into 2 semesters of 90 working days each. In each semester, students are required to undergo mid-term and end-term written examinations in each subject and submit a project research work in each subject (which includes a written submission and an oral presentation of the same). Thus, throughout the span of 10 semesters, each student is to undergo an intensive schedule of 4200 compulsory credit hours, 360 compulsory clinical hours, 76 written examinations, 540 days of work experience, 44 compulsory research papers, 8 compulsory seminar papers, and 44 compulsory oral presentations.



COURSES

NLIU hosts over 600 students enrolled in its graduate and undergraduate programs.

- The five-year integrated B.A. LL.B. (Hons.), B. Sc. LL.B. (Hons.) [Cyber Security] and the one-year LL.M. program accepts students through the intensive Common Law Admission Test (CLAT).
- The University also has a two-year post-graduate course of Master of Science in Cyber Law and Information Security (MSCLIS) as well as a Ph.D. program.
- The University has recently introduced an integrated B. Sc. LL.B. (Hons.) [Cyber Security] course which aims to blend law and technology and to impart a comprehensive understanding of the legal regime pertaining to Cyber Security, Data Protection, Blockchain Technology, Artificial Intelligence and multi-media protection.

The university's state-of-the-art infrastructure and abundant resources serve as the catalyst, propelling the students into a realm of diverse and meaningful activities. From academic pursuits to engaging in co-curricular adventures and championing social welfare initiatives, the student community thrives in an environment that nurtures holistic development.

Since its inception, the university fervently pursued its goals of research, knowledge dissemination, and outreach through an innovative approach. Its commitment is evident in the myriad of programmes, workshops, conferences, and seminars organised for students. What sets the university apart is its belief in student involvement, where they become integral architects in orchestrating and managing these activities through dedicated cells and centres within the University. Its collective efforts are meticulously designed to provide comprehensive legal education, infused with practical training, ensuring the students are well-prepared for the dynamic challenges of the professional world.

ACADEMIC PUBLICATIONS

NLIU, an abode for young thinkers, boasts of a rich academic culture that is reflected in its robust repository of student-run journals. NLIU's flagship journal, *NLIU Law Review* is one of India's leading journals having published 13 Volumes, aims to promote legal scholarship across fields of law. NLIU Law Review also conducts the NLIU Constitutional Symposium to promote discussion on various constitutional issues that arise and find legal solutions permissible within the four corners of the Constitution.

NLIU also houses several specialised journals like *Indian Arbitration Law Review ('IALR')*, the *Indian Trade Law Journal ('ITLJ')*, have emerged as platforms for critical engagement with Arbitration and Trade laws, bringing out perspectives from the Global South. Research Centres at NLIU also publish their own journals, including *NLIU Journal on Business Laws*, *CRIL Journal of International Law and Policy*, *Journal for Labour and Employment Law*, *Journal for Research in Competition Law and Policy*, *Journal for Legislative Drafting and Policy*, *Journal on Law and Gender*. The journals are indexed with prominent legal databases such as HeinOnline, Manupatra and SCCOnline.

NLIU also publishes contemporary publications in the form of blogs and newsletters. Blogs include [The NLR Blog](#), [The CBCL Blog](#), the [Blog on Intellectual Property Laws](#), the [Blog on Law and Technology](#), the [Blog on Civil and Criminal Laws](#), the [Blog on Law and Gender](#), the [Labour and Employment Law Blog](#), and the [NLIU CARES Blog](#). Some newsletters published include [The Corporate Brief](#), [NLIU-CSIPR Newsletter](#), etc.

The student-body has also published several ISBN-indexed student-edited books including, [ACING THE AI: ARTIFICIAL INTELLIGENCE AND ITS LEGAL IMPLICATIONS](#). The Research Review and Readers' Cell ('RRR') at NLIU is tasked to promote the skill to develop legal writing and produce well researched legal publications. RRR is in the process of publishing a ISBN book titled 'The Upcoming Recent Trends in Law and Justice: 2010-Present'. Further, RRR has also conducted a workshop, Academic Writing 101 – A Guided Research and Writing Workshop which aims to promote the skills of research and drafting among students.

ALUMNI OUTREACH AND ACTIVITIES

The NLIU Alumni Affairs Cell ('NAAC') works in collaboration with the NLIU Alumni Association with an aim to help students engage with the esteemed alumni of the University in a more meaningful manner. NAAC's annual flagship event, the NLIU Alumni Meet, aims to invite the alumni of the University back to campus, relive their cherished moments and connect with the students. NAAC maintains a database of all its alumni which serves as a bridge for other centres, faculty and the students. Further, NAAC also runs a mentorship programme called the NAAC - PCC Nexus Mentorship Programme wherein alumni working in diverse fields mentor students who wish to walk a similar career path. NAAC organises guest lectures by alumni, including a lecture by Ms. Anuja Pethia on Practical aspects of IBC, Mr. Adhitya Srinivasan on the new DPDP Act, etc.

The University, as part of its compulsory subjects, lays down the foundations of the understanding of corporate laws among the student community through subjects such as Company Law, Contract Law, Banking Law, Competition Law, Labour Law, Insurance Law and many more.

Further, the Centre for Business and Commercial Laws ('CBCL') takes the lead in organising a plethora of events and courses in collaboration with various leading law firms of the country to facilitate the same. CBCL has organised several events in association with leading law firms, where the Partners from these firms engage with students to provide practical insights. NLIU witnessed the 9th Edition of CBCL's flagship event - The NLIU Trilegal Summit on Corporate and Commercial Laws earlier this year. Additionally, CBCL has been successfully organising regular Certificate Courses such as the NLIU - Khaitan and Co. Course on Corporate Laws, the NLIU - IndusLaw Courses on TMT and Capital Markets, the NLIU - Saraf and Partners Course on Insolvency and Bankruptcy Laws and the NLIU- AZB Course on Energy Laws. CBCL has also launched 'Kaarobar', an initiative under which the students of the Cell give pro-bono legal assistance to start-ups, facilitating a mutual relationship with the clients that benefit from such assistance and the students that gain an immeasurable amount of practical knowledge. Centre for Research and Competition Policy Research ('CRCLP') also conducts and promotes research in Competition Law. CRCLP also publishes a blog on rolling basis to encourage students to research and write on contemporary competition issues.

LITIGATION AND ARBITRATION

The Moot Court Association ('MCA') is the official student body responsible for mooting and allied activities at NLIU. The MCA begins their training of the student community from the very beginning through the Freshers Moot Court Competition, designed to introduce first year students to mooting. Moreover, University Pools for moots and client counselling are also organised which gives students a plethora of opportunities to explore and participate in a number of mooting and co-curricular activities. MCA also organises one of India's most prestigious International Arbitration Moot Court Competitions i.e. the NLIU - Justice R.K. Tankha Memorial International Arbitration Moot. The 10th Edition is scheduled to be organised from the 5th to 7th April 2024. The 9th edition was hosted with support from the Singapore International Arbitration Centre, Allen and Gledhill LLP and J. Sagar Associates. The event witnessed participation from Universities across the globe. The MCA also organised the 5th NLIU- Singhanian & Partners National Client Counseling Competition which saw huge participation from various law schools.

Addressing the growing need and scope of alternate dispute resolution, NLIU's curriculum includes a Clinical Legal Course in ADR to train students in Arbitration and Mediation. Further, the Alternative Dispute Resolution Cell ('ADRC'), established in 2007, is one of the oldest Alternative Dispute Resolution Cells in the country. The 12th Edition of Asia's oldest and India's largest Mediation tournament - the NLIU - INADR International Mediation Tournament was hosted by the cell earlier this year. ADRC also ensures that students at NLIU are adequately trained in the art of negotiation and alternate dispute resolution by conducting regular training sessions and pools similar to MCA.

The Civil and Criminal Justice Cell ('CCJC') at NLIU has organised several competitions and workshops including the 1st National Workshop cum Competition on Drafting and Pleading conducted by Dr. Aman Hingorani, Senior Advocate, Supreme Court of India. The students of the fourth and the fifth year have also benefited from the lecture series on the newly introduced criminal laws of the country, undertaken by the faculty in-charge of the cell, Ms. Divya Salim.

LABOUR AND EMPLOYMENT LAWS

Centre for Labour Laws ('CLL') is established with the objective of providing a platform for research on policy, institutional, legal and regulatory issues centred on labour and allied benefits laws in India. The cell published its 1st edition of Journal on Labour Law in 2022. Another unique initiative of CLL is 'Snippets' wherein cell members analyse the latest judgements relevant to labour and employment laws in the form of a brief digest. One of the landmark achievements of CLL is that it submitted its recommendations for the draft rules under the newly adopted Occupational Safety, Health, and Working Conditions Code. In November 2023, CLL organised a National Workshop in association with the National Labour Law Association and Friedrich Ebert Stiftung, CLL organised the 3rd NLIU - Khaitan Global Symposium on Labour and Employment Laws.

INTELLECTUAL PROPERTY

NLIU offers a mandatory course on Intellectual Property Law equipping students with the knowledge of Intellectual Property Rights ('IPR'). Further an elective in Advance Patents is also offered to provide deep knowledge. The Cell for Studies in Intellectual Property Rights ('CSIPR') has organised various conferences and workshops in the field of IPR in collaboration with the Ministry of Human Resource Development and the Ministry of Industry and Commerce of the Government of India. The University also offers a unique opportunity to two students on fellowship to attend the prestigious IP Summer School for three weeks, each year, at the Centre for Advanced Studies & Research in Intellectual Property ('CASRIP') at the University of Washington, Seattle, in the United States of America.

CONSTITUTIONAL LAW AND PARLIAMENTARY STUDIES

NLIU believes in fostering critical scholarship in the field of Constitutional Law. The Centre for Parliamentary Studies ('CPS') aims to promote and facilitate research and activities in the field of Constitutional Law, Legislative Drafting, and Policy Research. CPS in this pursuit publishes the Journal on Legislative and Parliamentary Studies. Further, it also engages directly with the government and sends its comments on various bills and policy recommendations. Further CPS recently organised a visit of a student delegation to the Parliament of India in collaboration with PRIDE, Office of Lok Sabha.

NLIU in furtherance of its objective to provide students with an opportunity to discuss relevant legal updates, houses NLIU Manthan Centre for Knowledge and Policy Discussions ('Manthan'). Established in 2013, Manthan aims to foster an open environment of sharing of opinions, thoughts and ideas. Manthan has been instrumental in bringing forward burning issues to the conscience of students and has endeavoured to continuously and effectively engage with the student community. Manthan's activities include Baithaks where students come together to discuss their ideas on a relevant issue, Soch where students engage with an expert on a relevant legal issue. Manthan also publishes Manthan Monday which are snippets aimed to provide information on contemporary policy issues.

Centre for Tribal Studies and Research ('CTSR') has been formed with the objective to promote research in the field of laws and their implementation in tribal context keeping the constitutional values in mind. CTSR has undertaken various initiatives including field visits, collaborative guest lectures to promote awareness and discourse among students and professionals.

INTERNATIONAL LAW

The University has been rendering a noteworthy analysis of issues of national importance with an international perspective. The University curriculum on International Law gives students a broad perspective of Public International Law, International Relations and Private International Law including specialised areas such as International Humanitarian law, Refugee Law etc.

The Centre for Research in International Law ('CRIL') works to contribute to International Law scholarship. The NLIU CRIL Blog, which has been ranked amongst the top 40 International Law Blogs (worldwide) by Feedspot today. CRIL has contributed effectively to contemporary issues in international law by contributing to media inquiries and policy proposals.

NLIU has also fostered excellence in the budding area of International Trade law. This year, International Trade Law Journal ('ITLJ') conducted the first edition of its course on International Trade and Investment laws in collaboration with Centre for Trade and Investment Law ('CTIL') and the WTO Chair for India.

DATA PROTECTION

The Cell for Law and Technology ('CLT') was established in 2019 at NLIU with the primary aim of generating awareness and facilitating research initiatives in the field of technology laws. CLT recently organised the 2nd of their flagship tech-fest "**Techtonic**", which comprised panel discussions, debating and quizzing events, and the NLIU-Ikigai Policy Case Competition. CLT launched its newsletter Code & Counsel Chronicle, where the Cell shares its take on the latest trends and developments in technology law. The Cell also hosted the 10th episode of the CLT- Talk Show, a techno-legal webinar series wherein several eminent personalities discuss their insights on emerging technological innovations and their impact on the world. CLT has an active blog that features posts from Cell members and external contributors.

STUDENT ACTIVITIES

STUDENT BAR ASSOCIATION

The Student Bar Association ('SBA') operates as a democratic entity, deriving its authority exclusively from the student body of the National Law Institute University, Bhopal ('NLIU'), as stipulated in its constitution. The primary objective of the SBA is to foster amicable relations among students, faculty, and administration, thereby ensuring collective benefits for the entire NLIU community.

Throughout the academic year 2023-24, the unwavering dedication of the Student Bar Association has yielded notable accomplishments. The SBA includes an Advisory Council, which provides assistance to the SBA regarding academic matters and policy adjustments. Collaborative efforts between the SBA and the Advisory Council led to the implementation of an official menstrual leave policy applicable to students across all academic programs. Additionally, a Research Assistant Program was introduced to engage students in substantive research endeavors, offering them valuable hands-on experience and mentorship from seasoned faculty members. Furthermore, the SBA is actively involved in organising various sessions and initiatives such as Mental Health and Psychology Orientation Sessions, Blood Donation Camps, Cleanliness Drives, among others, aimed at enhancing the welfare of the student community.



CULTURAL ACTIVITIES

Cultural activities provide students with the opportunity to develop skills beyond reading and writing. They enable students to acquire new skills that can be applied to their lives, such as leadership, teamwork, collaboration, and problem-solving, thus preparing them for future challenges. **Athena**, the cultural society consisting of the Drama, Music, Dance, and Art Societies, organises various events throughout the year, such as Palchin, Ranganch, Open Mics, Dandiya Night, etc., as well as the flagship cultural and literary fest, MPzero4, which involves participation from students all over India.

Jus Cultura, our intellectual-creative powerhouse, endeavours to ignite and foster the brilliance of our student community through three dynamic societies. The Debating Society unleashes the ancient art of argumentation and liberates students from moot restraints. The Quizzing Society provides a workout for the mind, keeping the students intellectually charged. Last but not least, the Literary Society aims to creatively expose law students to their primary tool – Language. This is accomplished through activities such as storytelling, book reading and reviews, open mic sessions, poetry, etc.

The **Sports Committee** at NLIU conducts and encourages sporting activities throughout the college and organise extramural and intramural tournaments within the university. Additionally, the Sports Committee organises Virudhaka, the Biggest Sports Fest for Law Schools nationwide. In 2023, we organised the 13th Edition of Virudhaka, which witnessed the participation of students from all over India. Further, the Sports Committee also organises several sports leagues and interbatch tournaments to foster the sense of healthy competition among the students.



PRO BONO ACTIVITIES

The NLIU - **Legal Aid Clinic** ('LAC'), driven by the ethos of Article 39A of the Indian Constitution, was established in 2018 under the aegis of the National Legal Service Authority. It is a student-run initiative, which aims to provide free legal aid to the marginalised sections of society. They also organise various legal literacy workshops and training programmes to spread legal awareness to further the cause of legal literacy. It also has a research wing working under the name of 'Project Pukaar' which provides detailed legal research on topics affecting the society at large.

The **Pro-Bono Club** of National Law Institute University, Bhopal, operating under the auspices of the Department of Justice, embodies a noble mission of providing legal aid to those unable to afford it. Similar in its aim of increasing access to legal justice, the club raises legal awareness through Nukkad Natak, legal education drives to the grassroots level, and empowers individuals with knowledge of their rights and avenues for seeking legal recourse. The initiative has received acknowledgement from local daily newspapers such as Dainik Bhaskar for its groundbreaking work.

Motivated by the spirit of Article 21A and in their pursuit to help uplift the local community, the student body, through People United for Law Education and Rehabilitation ('PULER'), undertakes to provide education assistance and mentoring to primary and secondary school children in nearby villages such as Mendori, Mendora, and Kerwa. They also undertake initiatives to foster an inclination towards sports and cultural activities among the students through Bal Sabhas.

Increasing Diversity by Increasing Access - Madhya Pradesh Chapter ('IDIA') is dedicated to supporting underprivileged students in legal education. The organisation undertakes several key activities including sensitising underprivileged students about legal education, selecting and training them for law entrance examinations, conducting fundraising events, collaborating with NGOs for legal awareness sessions, and nurturing IDIA scholars who successfully crack CLAT (Common Law Admission Test). The Madhya Pradesh chapter, based at NLIU, has sensitized 430+ students and raised INR 1.24 lakh through an Essay Writing Competition. Four trainees cleared CLAT and got into top NLUs in the last 2 years. NLIU is pleased to share that some students trained by students of the Batch of 2025 are now a part of the NLIU family in the batch of 2028.



GENDER EDUCATION AND MENTAL HEALTH



The University has also been at the forefront of ensuring gender equality and promoting discourse on gender justice. NLIU organises the YES+ programme designed particularly for first year students aimed to promote the culture of meditation, yoga, and improve their spiritual and mental well being.

The **Gender Justice Cell** ('GJC') was established with this aim and continues to work relentlessly in raising concerns against the acts of injustice and discrimination perpetrated on grounds of sex, and addresses the causes and consequences of gender inequality both nationally and locally. GJC recently conducted its 1st Workshop on Gender and Law in collaboration with United Nations Women and Madhya Pradesh State Women's Commission in October, 2023.

INARA, the vibrant heartbeat of NLIU's queer and ally community, fosters inclusivity and acceptance through support, events, and advocacy. It is a sanctuary where diverse sexual orientations and allies find solace, solidarity, and strength. INARA organises sessions, support group events, and much more to induce dialogue and advocacy for Queer rights on campus.

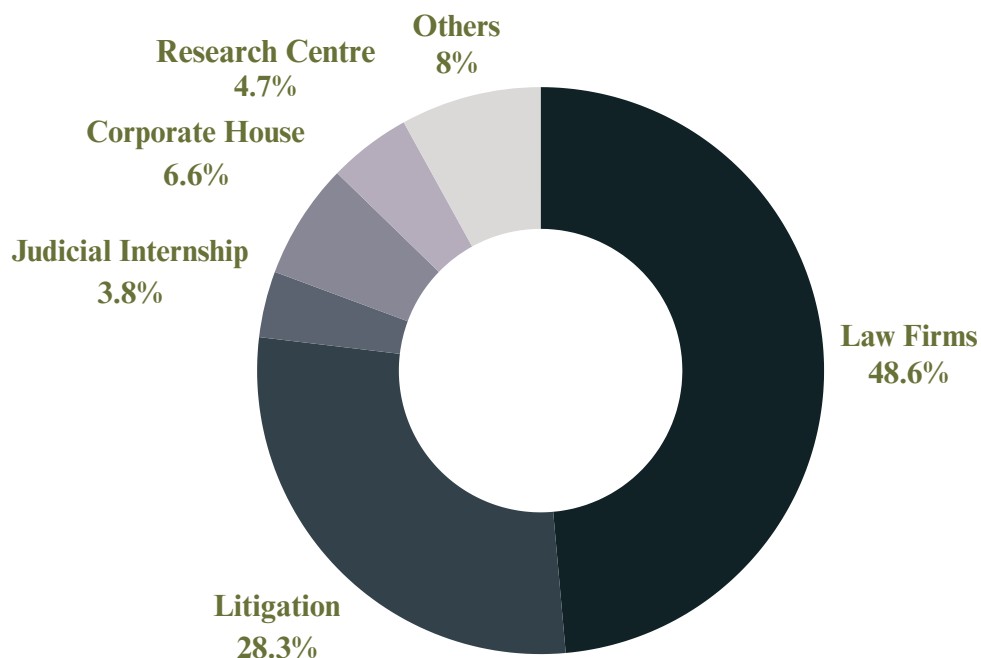

Placement Coordination Committee



The Placement Coordination Committee (“PCC”) holds the responsibility of facilitating the recruitment procedure at the University. The PCC provides a transparent, credible, and accountable interface between prospective employers and the graduating students. The representatives of each batch are selected by and work under the able guidance of the Faculty Coordinator, Dr. Sushma Sharma. The PCC is considered as an integral part of the University’s education system and contributes by organising various personality development and awareness programs as a part of the learning process for the students. The PCC is engaged in coordinating internships and placements, for which it seeks to instill functional knowledge and specific skills among the students by:

- Organising workshops and seminars conducted by various luminaries on topics which allows students to groom themselves for the high-demanding profession of law.
- Organising regular career counselling, mock interviews and group discussion programmes for the graduating batch.
- Providing regular counselling and personalised career guidance to the students.
- Maintaining a catalogue of recent developments in the field of law to generate awareness amongst students.

Day Zero

The University shall begin the campus placement process in the month of August, 2024 and Day Zero is scheduled from ___ to __August, 2024. The placement process continues till the end of the academic year of students in their fifth year, i.e., till April 2024.

3

Rolling Placements

The on-campus Placement Process continues after the Day Zero, throughout the year. It can be divided into Pre-Placement Session and the Recruitment Day.

4

Pre-Placement Talk

The recruiters have the option of engaging the students in an interactive session, either on-campus or through videoconferencing, highlighting the salient features of the organisation, the job profile being offered, remuneration, terms and conditions of employment and other relevant information as the recruiter thinks fit. They may also conduct lectures on niche areas of law. The recruiters are urged to indicate their preferred dates for such talks to the PCC, either by email or telephonic communication, at least a week in advance.

5

Recruitment Day

Recruiters are welcome to follow their own recruitment process, broadly within the framework of group discussions, written tests, and personal interviews. The PCC sits as an impartial judge to oversee that the processes are being carried out with utmost fairness that is the hallmark of this University and to ensure that the Recruiters are facilitated at every step in their assessment processes. Recruiters can also opt for Telephonic Interviews and interviews via Video Conferencing. The recruiters are requested to intimate the PCC with their preferred dates in the final placement schedule at the earliest.

Day Zero Process at NLIU

The PCC ensures optimal flexibility to all prospective recruiters. For Day Zero recruitments, the following broad steps may be followed by recruiters (the steps are not mandatory or exhaustive):

1. Recruiters may conduct Pre-Placement Talks (PPT) highlighting the profile of the organisation, career prospects, compensation packages, et al. These PPTs can be conducted at any time before the Pre-Interview Screening.
2. Recruiters may conduct a Pre-Interview Screening Process, including group discussions, at any time before the final interview. The Curricula Vitae of all interested students shall be forwarded to the recruiter, and the recruiters are free to determine their own policy for the Screening Process to shortlist students.
3. The recruiter shall formulate a Final Interview list subsequent to the completion of the Pre-Interview Screening Process or otherwise and the same must be communicated to the PCC along with a waitlist of students. All interviews being conducted on the same day may be conducted in different time slots.
4. All results shall be declared simultaneously by the PCC at the end of Day Zero to ensure that no recruiter is prejudiced. The recruiters will be required to disclose the results of their Final Interviews and any Offer made to applicant(s) only through the PCC. The recruiters are requested to disclose a Waitlist along with the final offers. In the event of overlapping offers, the waitlisted candidates will become eligible for the final offers.



Placement Rules

- If a member of the Placement Process receives an offer of employment independent of the PCC and accepts it, he/she will be barred from any further participation in the Placement Process.
- If a member of the Placement Process receives an offer of employment, it would be deemed to be an acceptance of the offer by the member. Thereafter, that member is barred from any further participation in the Placement Process.
- With more than one employer recruiting from the campus on the same day, the results will be declared after all the interviews for the day are over and if a candidate is selected by more than one organisation, the choice of selection lies with the candidate. Thereafter, the candidate is barred from any further participation in the Placement Process.
- The prospective employers are strongly urged to provide a waiting list of candidates along with the final offers. Only in the event of overlapping offers, the waitlisted candidates will become eligible for the final offer from the prospective employer, if such employer considers this appropriate.
- Decision of the Faculty regarding any dispute arising during the course of the entire Placement Process will be taken keeping in mind the larger interest of the students and will be final and binding on all interested parties.
