### PROCEDURE FOR ADMISSION UNDER THE CATEGORY OF J&K RESIDENT

- 1. The candidates who have applied in the CLAT-2025 under J&K Resident category, are required to:
  - (i) make an application expressing their interest for seeking admission at NLIU, Bhopal in the prescribed Expression ofInterest Form-A (given below).
  - (ii) Deposit an amount of ₹50,000/- (Rupees Fifty Thousand Only) only through electronic mode using <a href="https://erp.nliu.ac.in/payment/">https://erp.nliu.ac.in/payment/</a> latest by 10:00 a.m., of 15.05.2025 in NLIU Bhopal's account.
  - (iii) Submit the Duly filled-in Form-A at <u>admission@nliu.ac.in</u> and submit google from for B.A.LL.B. (Hons.) Course- https://forms.gle/qrZHvzTfZaxEcrUUA latest by 10:30 a.m. of 15.05.2025.
- 2. Submission of the Form-A through any other mode shall not be accepted. The names and other details of the candidates, whose Form-A have been received as per the above prescribed mode will be displayed at **www.nliu.ac.in** after the deadline of submission of Expression of Interest. If the name of a candidate who has complied with the conditions given in para 1 above buthis/her name is not appearing in this list, he/she may contact the university within 2 days after publishing of list of candidates whose forms have been received, failing which no request in this regard shall be entertained by the university.
- 3. A candidate who fails to comply with any of the three conditions given in para 1 above, it shall be conclusive that he/she is not interested in taking admission at NLIU Bhopal in J&K Resident (Supernumerary Quota) category and no request shall be entertained by the NLIU in this regard.
- 4. The amount of ₹50,000/- is non refundable but adjustable in the total fee payable by the candidate. However, the amount of ₹49,000/- will be refunded to the candidate if: (i) a candidate admission status is changed i.e. admitted in other category or moved to their higher preference by the CLAT-2025, or (ii) he/she is not admitted to NLIU, Bhopal. For claiming refund candidates are required to send deposit details (Form B) and bank account details for the refund of amount ₹49,000/- after the deduction of processing fee i.e.₹1,000/- (if eligible for refund) along with the Forms-A (given below).
- 5. A merit list, strictly according to CLAT-2025 Rank, of the candidates whose Form-A along with payment has been received in time will be published at www.nliu.ac.in.
