Important instructions for admission under NRI/NRI sponsored Category:

- 1) Only those candidates who have given the option as an NRI/NRI Sponsored in the CLAT-2025 application form alone will be eligible.
- 2) Where the applicant is an NRI/OCI Card Holder/PIO Card Holders and NRI Sponsored candidate by a First Degree or Second Degree, as indicated in CLAT-2024 Brochure of NLIU, Bhopal will be considered onmerit of CLAT-2025 Rank.

Procedure for admission under the category of NRI quota:

- 1. The candidates whose who have given option as an NRI/NRI Sponsored in the CLAT application form, are required to:
 - (i) make an application expressing their interest for seeking admission in the prescribed Expression of Interest Form-A (given below) at NLIU, Bhopal,
 - (ii) deposit an amount of ₹1,00,000/- (Rupees One Lac Only) only through electronic mode using https://erp.nliu.ac.in/payment/ latest by 10:00 a.m., of 15.05.2025 in NLIU Bhopal's account.
 - (iii) submit the Duly filled-in Form-I at <u>admission@nliu.ac.in</u> and submit google from for B.A.LL.B. (Hons.) <u>https://forms.gle/ZQu5F54SRv5rkSfV9</u> latest by 10:30 a.m. of 15.05.2025.
- 2. Submission of the Form-A through any other mode shall not be accepted. The names and other details of the candidates, whose Form-A have been received as per the above prescribed mode will be displayed at **www.nliu.ac.in** after the deadline of submission of Expression of Interest. If the name of a candidate who has complied with the conditions given in para 1 above buthis/her name is not appearing in this list, he/she may contact the university within given time period, failing which no request in this regard shall be entertained by the university.
- 3. A candidate who fails to comply with any of the three conditions given in para 1 above, it shall be conclusive that he/she is not interested in taking admission at NLIU Bhopal in NRI/NRI Sponsored category and no request shall be entertained by the NLIU in this regard.
- 4. The amount of ₹1,00,000/- is nonrefundable but adjustable in the total fee payable by the candidate. However, the amount of ₹99,000/- will be refunded to the candidate if: (i) a candidate admission status is changed i.e. admitted in other category or moved to their higher preference by the CLAT-2024, or (ii) he/she is not admitted to NLIU, Bhopal. For claiming refund candidates are required to send deposit details (Form-B) and bank account details for the refund of amount ₹99,000/- after the deduction of processing fee i.e.₹1,000/- (if eligible for refund) along with the Forms-A (given below).
- 5. A merit list, strictly according to CLAT-2025 Rank, of the candidates whose Form-A along with payment has been received in time will be published at www.nliu.ac.in.
