Advanced Certificate Programme in Company Law

The Companies Act, 2013 regulates a wide range of activities, including incorporation, operationalization, governance, liquidation and winding up of companies. Regulation of corporate governance and obligations of companies towards their stakeholders; conditions governing the issue of preferential shares, private placements and distribution of dividends; statutory disclosure obligations; powers of inspection, investigation and enforcement and company processes such as mergers / amalgamations / arrangements / reconstructions, etc., constitute the main focus of the Act. This course covers foundational and

advanced aspects of company law, including the latest amendments, judicial pronouncements, and emerging trends in areas such as corporate social responsibility (CSR), Special Acquisition Companies mergers and acquisitions, and ESG (Environmental, Social, and Governance) compliance. Participants will explore contemporary issues like digitalization in corporate compliance, data protection in corporate governance, and the evolving role of boards in fostering accountability and sustainability. Through interactive sessions, case studies, and expert-led discussions, the programme prepares attendees to navigate the complexities of modern corporate frameworks effectively, ensuring they remain at the forefront of legal and regulatory developments.

Advanced Certificate Programme in Labour Laws

The Certificate Programme will introduce students to the basic tenets of the Indian Labour Law regime. STEP 1

The candidate shall register by providing his/her basic details on the registration page. For complete details, please go through the Admission Notification, which is available on the Registration Page and the University website and proceed for filling the application form.

STEP 2

Fill all the details in the application form. All mandatory fields (with *) should be filled compulsorily.

Upload all the documents and the passport size photograph as listed in the application form

STEP 3

The After filling all the details PRESS 'SAVE' to save the data entered by you. Candidate may login and keep entering / modifying the data till payment is done.

STEP 4

After filling all the details, the next step is to make the Payment which can be made using the Online payment gateway. Please check the amount of fee from the Admission Notification for the selected programme, before making the payment.

STEP 5

If your payment transaction is successful, the fee receipt will be generated and the same along with the filled-in application form will be available on the DASHBOARD. If the payment transaction is failed then you need to do the payment again till your transaction is successful.

- Printed Copy of the Application Form is not required to be submitted. The candidates are advised to provide the correct information and upload all the relevant documents along with the passport size photograph without fail.
- The reading material and other information will be shared with the candidates as per the registered email provided by the candidates in the online application form. Incomplete applications will not be considered for admission.
- Candidates are required to keep a copy of the duly filled online application form and the payment acknowledgement with them for ready reference. If required, the University may ask for submission of the same along with all the attested documents at a later date.
