## **Terms and Conditions:**

- 1. The supplier may be asked to submit a sample of the product(s), which will be evaluated by a technical evaluation committee. The expenditure incurred for demonstrating the items will be borne by the supplier.
- 2. The work should be completed within 3 (tthree) days from the date of work order.
- 3. **Liquidated Damage**: If the contractor fails to complete work within specified period, then a penalty at the rate of 1.0 % per week of the total Work Order value shall be levied subject to maximum of 10% of the total work order value.
- 4. Payment Terms: Payment will be made only after satisfactorily delivery, commissioning and inspection of material by the NLIU, Bhopal. The payment will be made based on the actual measurement after satisfactory completion of the work and taxes will be deducted as per Govt rules.
