  - IV. Passing Certificate of 12<sup>th</sup> Class.
  - V. Mark Sheet of Graduation or its equivalent (Original and Photocopy) (For LL.M. and MCLIS candidates only)
  - VI. Seven copies of recent color passport size photographs in white shirt, black tie and black coat with red background as this photograph will be used for printing on the marksheet of the student of NLIU, Bhopal.
  - VII. Transfer Certificate in original.

- VIII. Migration Certificate in original.
- IX. Character Certificate in original.
- X. Affidavit of intervening period in original, if there is a gap of one or more year between the qualifying examination and the year 2025.
- XI. Government issued valid card such as Aadhaar Card, Driving License, Voter ID card etc.
- XII. Original Admit Card (CLAT-2025) for B.A.LL.B. (Hons.) , B.Sc.LL.B. (Hons.) [Cyber Security] and LL.M. Courses and original admit card for MCLIS Course.
- XIII. Original CLAT Score Card.
- XIV. Valid EWS Certificate, issued by competent authority, if applicable.
- XV. Original Caste Certificate, issued by competent authority, if applicable.
- XVI. Original Domicile Certificate, issued by competent authority, in case of M.P. State and J&K Residents, if applicable.
- XVII. Person with Disability Certificate, satisfying the norms of reservation in this category, issued by the competent authority, if applicable.

- \*OCI Card holders may submit a valid copy of OCI Card, proof of residence (valid copy of passport) in lieu of embassy letter for taking admission in the B.A.LL.B. (Hons.) & B.Sc.LL.B. (Hons.) [Cyber Security] Courses under NRI Sponsored Category. All other documents listed above and mentioned in the NRI/NRI Sponsored Rules 2025-26 are to be submitted.*
