Sealed quotations are invited by Registrar on Behalf of University for 'Refilling of Fire Extinguisher at NLIU campus, Bhopal's per terms and conditions mentioned below. **The Agency has to enclose its self-attested copies of PAN Card, GST Number, Firm registration certificate and 01 nos. work order for at least 50% of the total quantity of similar nature of work. The Agency has to enclose the concerned license/authorization certificate from the concerned Government authority for execution of refilling of fire extinguisher, if applicable.** The Firm should not be blacklisted by any Govt. Agency/Dept, undertaking on letter head to be submitted. The quotations with specific rates for the under mentioned item will be received up to 12.00 pm on 06.08.2024 and will be opened on the same day at 3.30 PM. The agency shall download the prescribed format our website: www.nliu.ac.in/tender.

The quotation should be addressed to the REGISTRAR, NATIONAL LAW INSTITUTE UNIVERSITY, NEAR KERWA DAM ROAD, BHOPAL-462044, superscribing the envelope with "**Refilling of 172 Nos. Fire Extinguisher at NLIU campus, Bhopal**".

Terms and Conditions:

Sealed Quotations are invited for "Refilling of Fire Extinguisher 172 Nos. at NLIU campus, Bhopal".

1. The work is of urgent nature and is to be completed within 10 days after issue of work order.
2. **Warranty: 12 months.**
3. The quotations received after this deadline & unsealed shall not be entertained under any circumstances whatsoever. In case of postal delay this Institute will not be responsible.
4. Rates must be quoted FOR basis (including Freight charges, Insurance, installation etc.)
5. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
6. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.



7. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
8. Contractor shall abide by labour rules and regulations.
9. All the applicable taxes shall be deducted from bill.
10. **Liquidated Damage:** If the supplier fails to deliver the material on or before the stipulated date, then a penalty at the rate of 0.5 % per week of the total order value shall be levied subject to maximum of 10% of the total order value.
11. No overwriting or cutting is permitted in the rate. If found, the quotation shall be summarily rejected.
12. The rates quoted must be valid for 60 days minimum from the date of opening of the quotation and silence of any tendered on this issue shall be treated as agreed with this condition.
13. Payment shall be made as per actual quantities of executed works. Payment will be only after satisfactorily delivery / commissioning of material and after inspection by the NLIU, Bhopal.
14. The quantity of items given in the Quotation is tentative, which may be increased or decreased as per the University requirement.
15. NLIU, Bhopal reserves the right to increase or decrease quantity and / or amount of work. Decision of Quantity of material in the NLIU, Bhopal will be final in this regard.
16. The right to accept a bid will rest with the National Law Institute University, Bhopal.
17. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.

3. After refilling paste inspection card to the body of the extinguisher indicating serial no. date of refilling, Next due date of refilling & due date of hydraulic testing.
4. For non-compliance of point no.2, penalty @ Rs. 100/- per extinguisher will be applicable o contractor.
