1. Sealed Quotations are invited for "Light Decoration Work for the Buildings of the NLIU, Bhopal".
2. The work is of urgent nature and is to be completed within days after issue of work order.
3. All damages done during execution of the work is to be made good by the contractor and nothing extra will be paid separately for the same.
4. The bidders should quote their rates based upon the Terms and Conditions forming part of quotation document.
5. In case, the date of submission/opening of tenders happens to be holiday, the tenders shall be received / opened on the next working day.
6. The right to accept a bid will rest with the National Law Institute University, Bhopal.
7. In case, the vendor fails to comply the terms & conditions, the University may terminate the contract without assigning any reason and is free to dispose of the waste paper items in such a manner as may be deemed appropriate.
8. It will be the responsibility of the vendor for the safety towards work and the cost towards transportation, packing, loading, unloading etc. will also be borne by the vendor himself.



9. Quotation should reach the Registrar office as mentioned. University is not responsible for any kind of postal delay.
10. All the applicable taxes shall be deducted from bill.
11. Contractor shall abide by labor rules and regulations.

15. Payment shall be made as per actual quantities of executed works.
16. Contractor should depute a qualified supervisor dedicated for this work, who will monitor and coordinate work from contractor's side and interact with the NLIUB Engineers, responsible for supervision of work, on regular basis.
17. During execution of work, Engineer may make minor changes in the scope of work as per site conditions or other reasons. Contractor will have no extra claim in his rates for the same.
