

## About Rajiv Gandhi National Cyber Law Centre (RGNCLC)

The Rajiv Gandhi National Cyber Law Centre (RGNCLC), established in 2006 at NLIU Bhopal by the Ministry of Human Resources Development (now, the Ministry of Education), GoI, New Delhi, through the UGC, is a premier Centre of Excellence in Cyber Law and Information Technology. The Centre owes its establishment to the efforts of Prof. (Dr.) Mool Chand Sharma, then Director of NLIU. RGNCLC is India's first Academic Centre dedicated to addressing techno-legal challenges of cyberspace and offers both regular and distance learning programmes.



It is among the few institutions in the country offering a Master's Degree in Cyber Law and Information Security. The Centre aims to develop skilled professionals capable of navigating complex issues in cyberspace and cybersecurity. Through rigorous research, practical training, and interdisciplinary learning, RGNCLC fosters a strong understanding of cyber laws, digital policies, and

regulatory frameworks preparing students to become future leaders, researchers, and innovators in the digital legal landscape.

The Rajiv Gandhi National Cyber Law Centre (RGNCLC) is the first centre of its kind established among all National Law Universities in India.

In alternative dispute resolution events, NLIU students secured top ranks at national and international mediation and negotiation competitions. Academic excellence was showcased through publications in top-tier journals such as *Trusts and Trustees* (Oxford University Press), and students earned accolades at symposiums and seminars on emerging legal domains, including AI, privacy, and intellectual property.

From competitive sports victories at IIM Indore and RNLU Patiala to quiz championships and national shooting competitions, our students demonstrated excellence in every field. These achievements not only underscore the University's commitment to holistic development but also reaffirm NLIU's position as one of India's premier institutions for legal education and professional development

### Alumni Achievements Chronicle: A Legacy of Excellence

Our alumni continue to make NLIU proud through their consistent professional advancements. Smarika Singh (2008) was promoted to Equity Partner at Shardul Amarchand Mangaldas, while Shreya Dua (2014), Pavi Jain (2013), and HIRAK Mukhopadhyay (2015) became Partners at Khaitan & Co. Similarly, Srideepa Bhattacharyya (2016) and Yashvi Singh (2013) attained Partner positions at Cyril Amarchand Mangaldas and JSA, respectively. In the corporate sector, Kunal Tiwari (2004) was appointed Managing Director – Legal at Accenture, and Swati Singh Baghel (2013) rose to the role of Managing Director at Blackstone. Younger alumni such as Alisha Mehra, Deeksha Malik, and Sakshi Malhotra (2018) became Principal Associates, while many from the 2020 and 2021 batches secured Senior Associate positions in leading law firms.

In the sphere of public service, NLIU alumni achieved top honors. Bishwajit Dubey (2004) and Apoorv Kurup (2005) were appointed Additional Advocates General for Chhattisgarh. Saurabh Mishra (2004) and Prakash Upadhyay (2005) were designated Senior Advocates by the Supreme Court and Madhya Pradesh High Court, respectively. Pratik Saraswat (2016) secured All India Rank 1 in the Assistant Labour Commissioner Exam, while Kashish Bakshi (2021) and Dhvani Agrawal (2022) ranked among the top 250 in the UPSC Civil Services Examination. Shradha Verma cleared the Judge Advocate General (JAG) Exam, and alumni Prakhar Marmat and Kushagra Srivastava were selected for the Delhi Judicial Services.

Several alumni also achieved national and international recognition. Ishani Chandra (2004) was named Managing Partner of the Year by BW Legal, while Anugya Mukati (2022) was honored as a Rising Star by Legal 500. Bishwajit Dubey and Vanshaja Shukla (2008) were appointed amicus curiae by the Delhi High Court and Supreme Court, respectively. Roshni Shanker (2005) collaborated with the UNHCR in co-hosting a litigation roundtable, and Ram Kumar (LL.M. 2021) was widely recognized for his key role in securing the conviction of a sitting MLA in a CBI case. Other prominent alumni such as Aakash Choubey and Anirudh Rastogi were featured in the 2025 Chambers and Partners Asia-Pacific rankings.
