B.A.LL.B.(HONS.) / B.Sc.LL.B. (HONS.) [CYBER SECURITY] OR BOTH B.A.LL.B.(HONS.) AND B.Sc.LL.B. (HONS.) [CYBER SECURITY] COURSES

Important instructions for admission under NRI/NRI sponsored Category:

- 1) Where the applicant is an NRI/OCI Card Holder/PIO Card Holders and NRI Sponsored candidates, as indicated in CLAT-2026 Brochure of NLIU, Bhopal will be considered on merit of CLAT-2026 Rank.
- 2) For B.Sc.LL.B. (Hons.) [Cyber Security] course only the candidates who have passed Intermediate/Higher Secondary Board Exam (10+2) in science stream or its equivalent are eligible. **(For further detail visit <https://nliu.ac.in/b-sc-ll-b-hons-cyber-security-admission/>)**
- 3) The candidates who are interested to apply for the B.A.LL.B.(Hons.) / B.Sc.LL.B. (Hons.) [Cyber Security] Or both B.A.LL.B. (Hons.) and B.Sc.LL.B. (Hons.) [Cyber Security] Courses under NRI/NRI sponsored Category, are required to follow the Procedure:
 - (i) make an application expressing their interest for seeking admission in the prescribed Expression of Interest Form-A (given below) at NLIU, Bhopal,
 - (ii) deposit an amount of ₹1,00,000/- (Rupees One Lac Only) only through electronic mode using https://ums.nliu.ac.in/AccSoft_NLIU/MiscellaneousPayment.aspx latest by 10:00 a.m., of 15.05.2026 in NLIU Bhopal's account.
 - (iii) submit the Duly filled-in Form-A at admission@nliu.ac.in and submit google form for B.A.LL.B. (Hons.) - <https://forms.gle/Ngxv1Zfu2G6xB2fdA> latest by 10:30 a.m. of 15.05.2026.
 - (iv) **In case of applying for both B.A.LL.B. (Hons.) and B.Sc.LL.B. (Hons.) [Cyber Security] Courses the candidate has to submit the forms and pay the fees for each application separately.**
 - (v) **If NRI Quota seats remain vacant after exhaustion of the merit list based on NRI/NRI Sponsored candidates Sponsored by the First-Degree Blood Relation or Second-Degree Blood Relation, such vacant seats will be offered to the NRI/NRI Sponsored by the Third Degree and other Blood Relations candidates.**
2. Submission of the Form-A through any other mode shall not be accepted. The names and other details of the candidates, whose Form-A have been received as per the above prescribed mode will be displayed at **www.nliu.ac.in** after the deadline of submission of Expression of Interest. If the name of a candidate who has complied with the conditions given in para 1 above but his/her name is not appearing in this list, he/she may contact the university within given time period, failing which no request in this regard shall be entertained by the university.
3. A candidate who fails to comply with any of the three conditions given in para 1 above, it shall be conclusive that he/she is not interested in taking admission at NLIU Bhopal in NRI/NRI Sponsored category and no request shall be entertained by the NLIU in this regard.
4. The amount of ₹1, 00,000/- is nonrefundable but adjustable in the total fee payable by the candidate. However, the amount of ₹99,000/- will be refunded to the candidate if: (i) a candidate admission status is changed i.e. admitted in other category or moved to their higher preference by the CLAT-2026, or (ii) he/she is not admitted to NLIU, Bhopal. For claiming refund candidates are required to send deposit details (Form-B) and bank account details for the refund of amount ₹99,000/- after the deduction of processing fee i.e. ₹1,000/- (if eligible for refund) along with the Form-A (given below).
5. A merit list, strictly according to CLAT-2026 Rank, of the candidates whose Form-A along with payment has been received in time will be published at www.nliu.ac.in .
