2. Copy of Certificate of being an NRI or a certificate of the relationship with the Sponsor to meet the requirements of NRI/NRI Sponsored Rules (see www.nliu.ac.in) for the rules relating to NRI/NRI Sponsored).
3. Letter from Embassy (NRI Certificate of the Candidate/Parents to be submitted in the Letterhead of the Embassy Office).
4. Letter from Embassy (PIO/OCI Certificate of the Sponsor to be submitted in the Letterhead of the Embassy Office).*
5. Certified copy of Passport of the Sponsor.
6. Declaration by the Candidate.
7. Declaration by the Parent/Guardian.

**OCI Card holders may submit a valid copy of OCI Card, proof of residence (valid copy of passport) in lieu of embassy letter for taking admission in the B.A.LL.B. (Hons.) & B.Sc.LL.B. (Hons.) [Cyber Security] Courses under NRI Sponsored Category. All other documents listed above and mentioned in the NRI/NRI Sponsored Rules 2025-26 are to be submitted.*

NRI / NRI SPONSORED RULES – 2026-27

Eligibility for admission under NRI/NRI Sponsored Category the candidate must be:

An NRI/OCI Card Holder/PIO Card Holder himself or herself,

OR

Sponsored by a First Degree or Second-Degree relation who is an NRI/OCI Card Holder/PIO Card Holder.

If NRI Quota seats remain vacant after exhaustion of the merit list based on NRI/NRI Sponsored candidates Sponsored by the First-Degree Blood Relation or Second-Degree Blood Relation, such vacant seats will be offered to the NRI/NRI Sponsored by the Third Degree and other Blood Relations candidates.

Meaning of First Degree / Second Degree relationship in case of NRI Sponsored candidates:

1. First Degree Relationship with the candidate means only the following:

Mother, Father, Full Brother, Full Sister, or Children as the case may be.

2. Second Degree Relationship with the candidate means only the following:

Maternal Grand Mother / Grand Father, Paternal Grand Mother / Grand Father, Real Maternal Aunt / Uncle, Real Paternal Aunt / Uncle, Half Maternal Sister / Brother, or Half Paternal Sister / Brother as the case may be.
