4. The amount of ₹1,00,000/- is nonrefundable but adjustable in the fee payable by the candidate. However, the amount of ₹ 99,000/- will be refunded to the candidate if: (i) a candidate's admission status is changed, i.e. admitted in another category or moved to their higher preference by the CLAT-2026, or (ii) he/she is not admitted to NLIU, Bhopal.
5. In case the name of a candidate who has complied with the conditions given in the notification dated 11.02.2026 but his/her name is not appearing in the above provisional list, he/she must contact the University latest by **01:00 p.m. of 18.05.2026**, failing which no request in this regard shall be entertained by the University.
6. A merit list, strictly according to CLAT-2026 Rank, of the candidates whose Form-I, along with payment, has been received in time will be published at www.nliu.ac.in.
