If the list of candidates sponsored by First-Degree Blood Relations or Second-Degree Blood Relations is exhausted, such vacant seats will be offered to NRI/NRI Sponsored candidates by Third-Degree Blood Relations and other Blood Relations.

 - g. CLAT-2026 Admit Card.
 - h. CLAT-2026 Score Card.
 - i. Copy of the fund transfer certificate/receipt to the NLIU bank account.
 - j. Copy of Certificate of being an NRI or a certificate of the relationship with the Sponsor to meet the requirements of NRI Sponsored Rules (see www.nliu.ac.in for the rules relating to NRI / NRI Sponsored).
