Any false or misleading information in this regard shall be illegal and will lead to revocation of this provisional offer and/or cancellation of admission during the course of study in B. A. LL. B. (Hons.) Course and NLIU shall be at full liberty to take appropriate legal action against such candidate and his/her sponsor.
2. In the above lists, the relationship with the sponsor as declared by the candidate himself/herself in the application form and is subject to verification by the admission committee. If the above relationship is found not to be correct as per the definition available on the university website, the candidate may not be considered under the respective NRI Sponsored Category.
3. Preference has been given to candidates sponsored by First-Degree Blood Relations or Second-Degree Blood Relations. If the list of candidates sponsored by First-Degree Blood Relations or Second-Degree Blood Relations is exhausted, such vacant seats will be offered to NRI/NRI Sponsored candidates by Third-Degree Blood Relations and other Blood Relations.
4. The candidates named in the Fifth Provisional Allotment List are required to **pay the requisite fee and report in person at Administrative Block of the University alongwith following documents on or before 31.07.2026** to complete the admission formalities:
 - a. Mark Sheet of 10th Examination.
 - b. Mark Sheet of 12th Examination or its equivalent.
 - c. Transfer Certificate.
 - d. Migration Certificate.
 - e. Character Certificate.
 - f. Affidavit Intervening Period in original, if there is a gap of one or more year between the qualifying examination and the year 2026.
 - g. CLAT-2026 Admit Card.
 - h. CLAT-2026 Score Card.
 - i. Copy of the fund transfer certificate/receipt to the NLIU bank account.
 - j. Copy of Certificate of being an NRI or a certificate of the relationship with the Sponsor to meet the requirements of NRI Sponsored Rules (see www.nliu.ac.in for the rules relating to NRI / NRI Sponsored).
