- k. Copy of the fund transfer certificate/receipt to the NLIU bank account.
- l. Valid EWS Certificate, issued by competent authority, if applicable.
- m. Original Caste Certificate, issued by competent authority, if applicable.
- n. Original Domicile Certificate, issued by competent authority, in case of M.P. State, if applicable.
- o. Person with Disability Certificate, satisfying the norms of reservation in this category, issued by the competent authority, if applicable.
